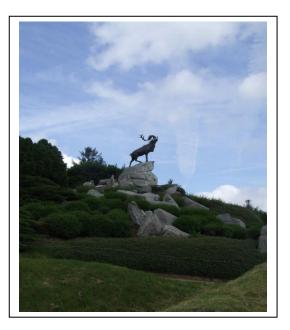


Private Otto Herbert Adams (Regimental Number 1770), having no known last resting-place, is commemorated on the bronze beneath the Caribou in the Newfoundland Memorial Park at Beaumont-Hamel.

His occupation prior to military service recorded as that of a *farmer*, Otto Herbert Adams was a recruit of the Sixth Draft. He presented himself at the *Church Lads Brigade Armoury* in St. John's, capital city of the Dominion of Newfoundland, on August 10 of 1915 for a medical examination. It was a procedure which was to pronounce him as being... *fit for Foreign Service*.



On the morrow of that medical assessment, August 11, he was to return to the *CLB Armoury* on Harvey Road, there to enlist. Nicholas Otto Herbert Adams was thereupon to be engaged at the daily private soldier's rate of a single dollar, to which was to be added a ten-cent per diem Field Allowance.

And it was then to be only twenty-four hours afterwards again that there then came the final formality of his enlistment: attestation. On the following day, August 12, he pledged his allegiance to the reigning monarch, George V, at which moment Otto Herbert Adams thereupon became...a soldier of the King.

A further, and lengthier, waiting-period was now in store for the recruits of this draft, designated as 'G' Company, before they were to depart from Newfoundland for...overseas service.

Private Adams, Regimental Number 1770, was not to be again called upon until October 27, after a period of eleven weeks less a day. Where he was to spend this intervening time appears not to have been recorded although he possibly returned temporarily to his work and surely would have been able to spend time with family and friends on Belvedere Street at the extremity of the city (and just before the old railway track – today Empire Avenue) - but, of course, this is only speculation.

On the above-mentioned date of October 27, 'G' Company left St. John's by train to cross the island to Port aux Basques, the other passengers on board reportedly having included several naval reservists and also some German prisoners-of-war. The contingent then traversed the Gulf of St. Lawrence by ferry – documented as having been the *Kyle* - and afterwards proceeded again by train from North Sydney as far as Québec City.

There the Newfoundlanders joined His Majesty's Transport *Corsican* for the trans-Atlantic voyage to the English south-coast naval establishment of Devonport where they arrived on November 9. The vessel had departed Montreal on October 30 with Canadian troops on board before stopping at Québec: the 55th Canadian Infantry Battalion and the Second Draft of the (1st?) Divisional Signals Company.

By the morning of November 10, Private Adams' 'G' Company had again travelled by train, to Scotland where it had been billeted in huts in a military camp at Gailes, not far removed from the evolving Newfoundland Regimental Depot at Ayr where accommodation for the new arrivals was as yet not available.

* * * *

More than a year prior to that November 10 of 1915, in the late summer and early autumn of 1914, the newly-formed Newfoundland Regiment's first recruits had undergone a period of training of five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's and elsewhere in the city, and were formed into 'A' and 'B' Companies.



During that same period the various authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after a recruit's enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.

The ship had sailed for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1st Canadian Division overseas, off the south coast of the Island.

Once having disembarked* in the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the Salisbury Plain; then in Scotland at Fort George — on the Moray Firth close to Inverness; and lastly at Edinburgh Castle — where it was to provide the first garrison from outside the British Isles.



*It was to do so at Devonport through which 'G' Company would pass eleven months later.

Only days after 'A' and 'B' Companies had taken up their posting there, on February 16 of 1915, 'C' Company – the first re-enforcements for the original contingent - would arrive directly – through Liverpool of course - from Newfoundland. On the final day of the month of March it had been the turn of 'D' Company to arrive – they via Halifax as well as Liverpool – to report...to duty...at Edinburgh, and then 'E' Company five weeks less a day later again, on May 4*.

*These five Companies, while a contingent of the Newfoundland Regiment, did not as yet comprise a battalion and would not do so for a further five months – as will be seen below.

Seven days after the arrival of 'E' Company in the Scottish capital, on May 11 the entire Newfoundland contingent had been ordered elsewhere. On that day, seven weeks into spring – although in Scotland there was apparently still snow - the unit had been dispatched to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, close to the town of Hawick.

Two months less a day later, on July 10, 'F' Company would march into *Stobs Camp*.

This had been an important moment: the Company's arrival was to bring the Newfoundland Regiment's numbers up to some fifteen hundred, establishment strength* of a battalion which could be posted on...active service.

From *Stobs Camp*, some three weeks after the arrival of 'F' Company, in early August 'A', 'B', 'C' and 'D', the four senior Companies, having now become the 1st Battalion of the Newfoundland Regiment, had been transferred to *Aldershot Camp* in southern England. There they were to undergo final preparations – and a royal inspection – before the Battalion's departure to the Middle East and to the fighting on the *Gallipoli Peninsula*.

The later arrivals to the United Kingdom, 'E' and 'F' Companies, were to be posted to the new Regimental Depot and were eventually to form the nucleus of the soon to be formed 2^{nd} (*Reserve*) Battalion of the Newfoundland Regiment.

The Regimental Depot had been established during the summer and the early autumn of 1915 in the Royal Borough of Ayr on the west coast of Scotland, there to serve as a base for the newly-forming 2nd (*Reserve*) Battalion. It was from there – as of November of 1915 – that the new-comers were to be sent in drafts, at first to *Gallipoli* and then subsequently to the *Western Front*, to bolster the four fighting companies of the 1st Battalion*.





*The first such draft was, in fact, to depart from Ayr for service on the Gallipoli Peninsula days after the arrival in Scotland of Private Adams' 'G' Company, on November 15.

This then had been the situation facing the new-comers: the new Regimental Depot had still been in the throes of its establishment when Private Adams and his comrades-in-arms of 'G' Company were to arrive in Scotland on November 10 of 1915; thus, as related in a preceding paragraph, the new-comers were required to be quartered at Gailes, some sixteen kilometres further up the coast – but apparently more than sixty kilometres distant by road.

Then, some twenty-eight weeks after having reported to Gailes those several months before in November of 1915, on May 24 of the spring of 1916 - and three weeks before his eventual departure on active service – Private Adams was prevailed upon to re-enlist...for the duration of the War*.

*At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for a limited period of a single year. As the War progressed, however, this would likely cause problems and they were encouraged to re-enlist. Later recruits signed on for the 'Duration' at the time of their original enlistment.

By the time that he, Private Adams, was eventually to sail from the United Kingdom to...active service...he had witnessed the departure of five re-enforcement drafts from Ayr: In mid-November the first – already cited in an earlier paragraph - had sailed for the Middle East to serve at Suvla Bay on the Gallipoli Peninsula; the second had been a convoluted adventure – the draft had taken ship in mid-March for Egypt but upon arrival there had been obliged to turn around for a return voyage as far as the French Mediterranean portcity of Marseille. From that time on, however, the drafts were all to proceed directly across the English Channel to France.

It was on June 14 of 1916, that the 6th Re-enforcement Draft – with Private Adams among its ranks - passed through the English south-coast port of Southampton en route to the Continent. On the following day, the 15th, it disembarked in Rouen, the capital city of Normandy and the site of the large British Expeditionary Force Base Depot where the contingent was now to spend time in final training and organizing* before moving on to a rendezvous with the parent 1st Battalion of the Newfoundland Regiment.

*Apparently the standard length of time for this final training at the outset of the war had been ten days – although this was to become more and more flexible as the War progressed - in areas near Rouen, Étaples, LeHavre and Harfleur that became known notoriously to the troops as the Bull Rings.

A draft of sixty-six men from Rouen – Private Adams one of that number - would arrive to join the parent unit at Louvencourt on June 30*. At 9:15 that same evening, most of the Newfoundlanders – minus the ten per cent Reserve Company** but including many of the new-comers - marched from there to their assigned...forming-up place trenches i.e. rear line of trenches in our usual sector (from the 1st Battalion War Diary).

*Had the attack gone ahead on June 30 as initially had been planned, those men might not have been flung into the imminent maelstrom. Bad weather – fog which had restricted aerial surveillance – had decided the High Command to postpone the attack for one day.

**Private Adams was to march with these re-enforcements on the next day.

* * * * *

A year prior to this juncture, in the early summer of 1915, the Regimental Depot in Scotland had only just been beginning to evolve: both 'E' and 'F' Companies had only then been beginning their time of training at Ayr; as for Otto Herbert Adams, he was as yet only at the point of enlistment and attestation at home, and he still had some three months to wait before the call was to come to sail overseas to the United Kingdom.

The aforementioned four senior companies, 'A', 'B', 'C' and 'D', of the Newfoundland Regiment, having now become the 1st Battalion had at this same time been attached to the 88th Infantry Brigade of the 29th Division of the (British) Mediterranean Expeditionary Force and had been dispatched to...active service.

On August 20 of 1915, the Newfoundland Battalion had embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1st Battalion was to land at *Suvla Bay* on the *Gallipoli Peninsula*.

When the Newfoundlanders had landed from their transport ship at *Suvla Bay* they were to disembark into a campaign that was already on the threshold of collapse.

Not only in the area where the Newfoundland Battalion would now serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had been proving to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command* had ever anticipated – were eventually to overwhelm the British-led forces and those of their allies, the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

*Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.



November 26 would see what perhaps was to be the nadir of the Newfoundland Battalion's fortunes at *Gallipoli*; there was to be a freak rain, snow and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, had been those afflicted by trench-foot and by frost-bite.

By this time the situation there had daily been becoming more and more untenable, thus on the night of December 19-20, the British had abandoned the entire area of *Suvla Bay* – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard. Some of the Battalion personnel had thereupon been evacuated to the nearby island of Imbros, some to Lemnos, further away, but in neither case was the respite to be of a long duration; the 1st Battalion would be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and *Anzac* forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – had by now simply been marking time until a complete withdrawal of the *Peninsula* could be undertaken.

This final operation would take place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

*Lieutenant Owen Steele of St. John's, Newfoundland, is cited as having been the last soldier of the Mediterranean Expeditionary Force to step into the final small boat to sail from the Gallipoli Peninsula.

Immediately after the British evacuation of the *Gallipoli Peninsula*, the Newfoundland unit had been ordered to the Egyptian port-city of Alexandria - and beyond. On January 14, the Australian Expeditionary Force Transport *Nestor* had arrived there with the 1st Battalion on board. The vessel was to sail just after mid-day on the 16th, on its way southwards down the Suez Canal to Port Suez where she had docked early on the morrow and where the Newfoundlanders had landed and marched to their encampment.

There they were to await further orders since, at the time, the subsequent destination of the British 29th Division had yet to be decided*.

*Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was already becoming a theatre of war.

After a two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and other ranks of the 1st Battalion were to board His Majesty's Transport Alaunia at Port Tewfiq, on March 14 to begin the voyage back up through the Suez Canal en route to France. The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseille, on March 22.

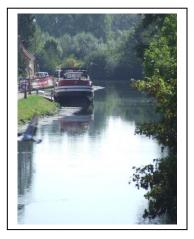
Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseille.



It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon. Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge which they had then traversed on their way from the station. But some three months later *the Somme* was to have become a part of their history.

On April 13, the 1st Battalion had subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive reenforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the Western Front.

Just days following the Newfoundland Battalion's arrival on the *Western Front* in mid-April, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit* before the entire Newfoundland unit was to then be ordered to move further up for the first time into forward positions on April 22.

*It should be said that the Newfoundland Battalion and twohundred men of the Bermuda Rifles who were serving at the time in the 2nd Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.

Having then been withdrawn at the beginning of that month of May to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, the Somme, that flowed – and still does so today – through the region.

And it was, as related in an earlier paragraph, on the very eve of the onset of that campaign that Private Adams' draft of sixty-six men dispatched from the Base Depot at Rouen, arrived to report to the 1st Battalion at Louvencourt.

* * * * *

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went over the top in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later*.

*Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.

There are other numbers of course: the fiftyseven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been...killed in action...or...died of wounds.

It was to be the greatest disaster *ever* in the annals of the British Army...and, perhaps just as depressing, the carnage of *the Somme* was to continue for four and a half months.

In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land separating Beaumont from Hamel.

Private Adams was not one of those who marched away from Louvencourt on the evening of June 30, and thus he was not to figure in the fighting of the morning of July 1 with the Newfoundland Battalion at Beaumont-Hamel; he was one of that ten per cent reserve held at Louvencourt and not called forward until about two o'clock in the afternoon of that day when the fighting had greatly subsided.



*The well-known roll-call of July 2 of those who survived the battle unscathed was not officially recorded until two days later. The roll call of those who had been in the ten percent reserve of fourteen officers and eighty-three men held back for most of the day at Louvencourt was apparently also recorded officially only later. Thus the inscription 'With Battalion 4/7/16' on certain records.

After the events of the first day of the... First Battle of the Somme, such had then been the dire condition of the attacking British forces that it had been feared that any German counter-assault might well annihilate what had managed to survive of the British Expeditionary Force on the Somme.

The few remnants of the Newfoundland Battalion – and of the other depleted British units - had thus remained in the trenches perhaps fearing the worst, and at night searching for the wounded and burying the dead. It was to be July 6 before the Newfoundlanders were to be relieved from the forward area and to be ordered withdrawn to Englebelmer.

It had then been a further two days before the unit had marched further again to the rear area and to billets in the village of Mailly-Maillet.

There on July 11, a draft of one-hundred twenty-seven reenforcements – a second source cites one-hundred thirty – had reported to duty. They had been the first to arrive following the events at Beaumont-Hamel but even with this additional manpower having arrived, the Regimental War Diary records that on the 14th of July, 1916, the 1st Battalion was still to number only...11 officers and 260 rifles...after the holocaust of Beaumont-Hamel, just one-quarter of establishment battalion strength.



Ten days later a further re-enforcement draft from the Regimental Depot at Ayr had arrived via the Divisional Base Depot at Rouen and had presented itself in the community of Acheux to which the 1st Battalion had withdrawn four days before.

Days later, having marched from Acheux to the provincial town of Beauval, on July 27-28 of 1916, the 1st Battalion - still under establishment battalion strength at only five-hundred fifty-four strong, maybe fewer even after a third reenforcement draft of sixty other ranks on July 24 - moved northwards and entered into the Kingdom of Belgium for the first time.

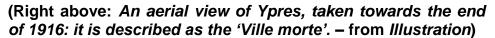


It had been ordered to the Ypres Salient, one of the most dangerous pieces of real estate on the entire Western Front, there to continue to re-enforce and to re-organize after the ordeal of Beaumont-Hamel.

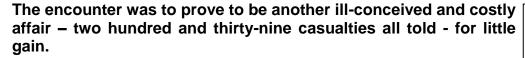

The Salient - close to the front lines for almost the entire fifty-two month conflict - was to be relatively guiet during the time of the Newfoundlanders' posting there; yet they nonetheless would incur casualties, a number - fifteen? - of them fatal.

Then on October 8, after having served in Belgium for some ten weeks, the Newfoundland Battalion had been ordered to return south, back into France and back into the area of - and the battle of - the Somme.



Four days after that return to France, on October 12, 1916, the 1st Battalion of the Newfoundland Regiment had again been ordered to the offensive; it was to be at a place called Gueudecourt, the vestiges of a village some dozen or so kilometres to the south-east of Beaumont-Hamel.

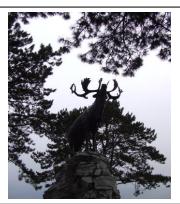

After October 12, the Newfoundland Battalion was not to be immediately directly involved in any further concerted infantry action in the immediate area of Gueudecourt although, on October 18, it had supplied two-hundred fifty men to act as stretcher-bearers in an attack undertaken by troops of two British regiments, the Hampshires and the Worcestershires, of the 88th Brigade.

On October 30, the Newfoundland unit had eventually been retired to rear positions from the Gueudecourt area. It had been serving in front-line and support positions for three weeks less a day.

The Newfoundlanders were now to spend two weeks withdrawn to the area of Ville-sous-Corbie, re-enforcing and reorganizing and it was not to be until November 15 that the 1st Battalion began to wend its way back up to the front lines.

There it continued its watch in and out of the trenches of the Somme – not without casualties – during the late fall and early winter, a period broken only by another several weeks spent in Corps Reserve during the Christmas period, encamped well behind the lines and in close proximity to the city of Amiens.

After those Christmas festivities – turkey dinner washed down with...real ale...apparently – it was not to be until January 11 that the Newfoundland Battalion would be ordered out of Corps Reserve and from its lodgings at Camps en Amienois to make its way on foot to the community of Airaines. From the railway station there it entrained for the small town of Corbie where it thereupon took over billets which it had already occupied for a short period only two months before.

After that recent six-week Christmas respite spent in *Corps Reserve* far to the rear, the Newfoundlanders were to *officially* return to *active service* on January 23, although they apparently had already returned to the trenches by that date and had incurred their first casualties – and fatality – of 1917.

Those casualties, however, were to be only some of those everyday thousands whom Douglas Haig somewhat cavalierly referred to as *wastage* since the Newfoundland unit did not venture from its trenches during those several days.

However, that winter period – as had been and was to be the case of all the winter periods of the Great War – would be a time of relative calm, although cold and uncomfortable for most of the combatants of both sides. It was a time of sickness, and the medical facilities

were kept busy, particularly, so it seems - from at least Canadian medical documentation - with thousands of cases of dental work.

And as has been related in an earlier paragraph, this period also provided the opportunity to undergo training and familiarization with the new practices and weaponry of war; in the case of the Newfoundland Battalion this was at least partially undertaken in the vicinity of the communities of Carnoy and Coisy.

On February 18 the 1st Battalion began a five-day trek back from Coisy to the forward area where it went back into the firing-line on February 23, relieving a unit of the 1st Lancashire Fusiliers. It was at a place called Sailly-Saillisel and the reception offered by the Germans was lively: after only two days the Battalion had incurred four dead, nine wounded and three gassed without there having been any infantry action. The Newfoundlanders were withdrawn on February 25 to return three days later.



They carried with them orders for a...bombing raid...on the enemy positions at Sailly-Saillisel...to be carried out on March 1.

In fact, the sole infantry activity *directly* involving the Newfoundland unit during that entire period – from Gueudecourt in mid-October, 1916, until Monchy-le-Preux in mid-April of 1917 – was to be that sharp engagement at Sailly-Saillisel at the end of February and the beginning of March, an action which would bring this episode in the Newfoundlanders' War – in the area of *the Somme* - to a close.

After Sailly-Saillisel the month of March would be a quiet time for the Newfoundlanders; having departed from the trenches, they were now to spend their time near the communities of Meaulté and Camps-en-Amienois re-enforcing, re-organizing, and in training for upcoming events. They even had the pleasure of a visit from the Regimental Band come from Ayr, and also one from the Prime Minister of Newfoundland, Sir Edward Morris, the latter on March 17, St. Patrick's Day.

On March 29, the Newfoundlanders began to make their way – on foot – from Camps-en-Amienois to the north-east, towards the venerable medieval city of Arras and eventually beyond, the march to finish amid the rubble of the village of Monchyle-Preux.

On April 9 the British Army was to launch an offensive in the area to the north of *the Somme* battlefields; this was to be the so-called *Battle of Arras*, intended to support a major French effort elsewhere. In terms of the daily count of casualties – just over four thousand - this attack was to be the most expensive operation of the *Great War* for the British, its only positive episode to be the Canadian assault of *Vimy Ridge* on the opening day of the battle, Easter Monday, 1917.



And while the British campaign would prove an overall disappointment, the French *Bataille* du Chemin des Dames was to be yet a further disaster.

The 1st Battalion was to play its part during the *Battle of Arras*, a role that would begin at the place called Monchy-le-Preux on April 14 and which would finish ten days later, on April 23, perhaps a kilometre distant, at *Les Fosses Farm*. After Beaumont-Hamel, the ineptly-planned action at Monchy-le-Preux would prove to be the most costly day of the Newfoundlanders' war, four-hundred eighty-seven casualties all told on April 14 alone*.



*It was also an action in which a DSO, an MC and eight MMs were won by a small group of nine personnel of the Battalion – the Distinguished Service Order (DSO) awarded to the unit's Commanding officer. An MM for the same action was also presented to a private from the Essex Regiment.

* * * * *

Four days before the attack at Monchy-le-Preux, on April 10, while on the march towards Arras, Private Adams had apparently already incurred the displeasure of his superiors and, although the exact charge seems not to be documented among his files, he was awarded seven days of *Field Punishment No. 2* – being kept in shackles, but in all likelihood only when not marching - by his Commanding Officer.

But the worst was yet to come:

...Charged with desertion for leaving the trenches while under shell-fire, he was found guilty and was sentenced* to suffer death by being shot. This sentence was commuted to one of ten years PS** to be suspended, suspension to date 31/5/17 but the case will be brought forward for further consideration on 31/8/1917 - KIA 9/10/17

There seem to be no record as to when Private Adams re-joined his unit. However, most likely it was after or even on May 31, 1917, the date on which his sentence was suspended, since he surely up until that time would have been held in confinement

It is not clear from his files whether the ten days of Field Punishment and the Court-Martial are related, except that he was awarded the FP for ten days on April 10 and then only four days later, on April14, was in prison awaiting trial – all of which suggests that they were.

Neither does there appear to exist among the available documents any detail of the charge brought against him apart from...'leaving the trenches while under shell-fire': the last time that the unit had been exposed to enemy artillery-fire had been at Sailly-Saillisel on the first days of March.

His case went as high as the Commander-in-Chief of the Third Army, Lieutenant-General Allenby, who approved the above commutation until the last day of August. (He, Allenby, was replaced as C-in-C on June 9.) At some time before that August 31 the sentence was again commuted for further consideration, on this occasion by the Officer Commanding the 88th Infantry Brigade – to which the 1st Newfoundland Battalion was attached – Lieutenant-Colonel Nelson: the new date was to be November 30, 1917.

* * * * *

After the further debacle of April 14, the remnants of the Newfoundland Battalion remained in the area of Monchy-le-Preux for but a few days. Its casualty count had been high enough to warrant that it and the Essex Regiment, which had also incurred heavy losses, be amalgamated into a composite battalion until such time as incoming re-enforcements would allow the two units' strengths to once more resemble those of bona fide battalions.

When the other thirty-nine *other ranks* of a re-enforcement contingent from Rouen reported to the 1st Battalion on April 18, they were just in time to march the dozen kilometres or so from Arras up to the line to take over trenches from the Dublin Fusiliers. They were only two hundred twenty – plus twelve officers in number - now serving with some two hundred of the Essex Regiment in the aforementioned composite force. Those of the 1st Battalion spent the 19th salvaging equipment and burying the dead. They remained there until the 23rd.

The final action in which the Newfoundland Battalion was to be involved during the five-week long *Battle of Arras* would be the engagement of April 23 at *Les Fosses Farm*. This was in fact an element of a larger offensive undertaken at the time by units of the British 5th, 3rd and 1st Armies.

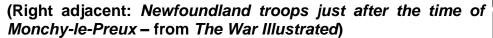


It was apparently not to be a particularly successful venture, at least not in the area of the 1st Battalion, several of the adjacent units reporting having been driven back by German counter-attacks, actions accompanied by heavy losses.

And the Newfoundlanders had sustained further losses: ten...killed in action, three ...missing in action, and forty-eight...wounded.

Late, on that same evening of April 23, the Newfoundlanders had retired the dozen or so kilometres to the relative calm of Arras.

The Battle of Arras was now proceeding to its costly and inconclusive close in mid-month, but the Newfoundland unit was not to be further involved in any further co-ordinated offensive action – it was too exhausted; this now would be a period when the Battalion was to be moving in a circular fashion on the Arras front, in and out of the trenches.







On May 7 it was on the move once again and marching to different billets in Berneville where it was to be the subject of a war journalist and photographer.

At the outset of June, the 1st Battalion had retired from the line to Bonneville, there to spend its time again re-enforcing, re-organizing and in training for the upcoming British offensive of the summer – and as it transpired, the autumn as well.

And, as suggested above – but without any evidence to offer – this may have been the moment when Private Adams was to re-join the Newfoundland Battalion.

* * * * *

The Newfoundlanders were then soon once again to be moving north into Belgium – at the end of June - and once again into the vicinity of Ypres and...the Salient, their first posting to be to the banks of the Yser Canal just to the north of the city.

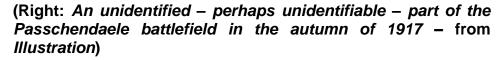

This low-lying area, Belgian *Flanders*, the only part of the country unoccupied by German forces, had been selected by the High Command to be the theatre of the British summer offensive of 1917.

Officially designated as the *Third Battle of Ypres*, the campaign was to come to be better known to history simply as *Passchendaele*, having adopted that name from a small village on a not-very high ridge to the north-east that later was to be cited as having been – *ostensibly* - one of the British Army's objectives.



The 1st Battalion of the Newfoundland Regiment was to remain in Belgium until October 17, a small cog in the machinery of the British Army. This had been or was also to be the case with the Australians, the New Zealanders and the Canadians, all of whose troops had floundered or would soon flounder their way across the sodden and shell-torn countryside of Belgian Flanders.

Notably the Newfoundland Battalion at *Passchendaele* was to fight in two major engagements: at the *Steenbeek* on August 16; and at the *Broembeek* (see both immediately below) on October 9.

At the former it had incurred nine *killed in action*, ninety-three wounded, and one missing in action; at the Broembeek the cost would be higher: forty-eight killed or died of wounds, one-hundred thirty-two wounded and fifteen missing in action.

Private Reid was most likely to have served at the *Steenbeek*. But he was not to do so at the *Broembeek*; nor was he then seem to have served with the Newfoundland Battalion during the *Battle of Cambrai* (see below) in November of 1917 – but he may have done so with another unit of the 88th Brigade

The son of Thomas Daniel Adams (former stonemason, labourer, farmer, deceased February 22, 1920) and of Theresa Frances (Fanny) Adams (née Holloway*) – to whom he had allotted a daily allowance of sixty cents from his pay and to whom he had willed his all - of 26, Belvedere Street, St. John's (later of 81, LeMarchant Road) - he also was brother to Beatrice-Blanche, Victoria, Minnie-Emma, Alexander, Frederick-William, James-Pulner, Thomas, and Ernest.



*The couple married on October 17, 1885.

Private Adams was at first reported as...missing in action...on October 9, 1917, while serving with 'A' Company during the fighting at the *Broembeek*, Belgium, during *Third Ypres: Passchendaele*.

However, a subsequent report dated 18/12/17 and submitted by a Lieutenant Massey, 50th Division *Salvage & Burial Officer*, recorded the identification of his remains and their interment on or about that same date. Private Adams' documentation was thus amended so as to read...*killed in action or died of wounds on or shortly after 9/10/1917.*

Otto Herbert Adams had enlisted at the *declared* age of eighteen years and three months – although his mother also claims him to have enlisted at age sixteen years and six months*. (Thus far his date of birth has been elusive.)

*She also claimed that the effects later sent to her were not those of her son, despite the affirmation of such by the authorities. Apparently the belt sent back was that of the Ambulance Service, and amongst his other 'possessions' were post-cards, a book of poetry and a French dictionary – curious items indeed for a young man who could neither read nor write.

Private Otto Herbert Adams was eligible for the British War Medal (on left) and also the Victory Medal (Inter-Allied War Medal).

Reference attached. Having been able to get in touch with the NCO attached to Lieut. Massey whilst he was acting as Burial Officer, I am enabled to give you the following particulars. The effects as sent to the Base on 6/11/17 were obtained from a partially buried body found by Lieut. Massey's party in the neighbourhood of Langemark, Belgium, and it was therefore presumably the body of the above-mentioned soldier as a Paybook was obtained bearing

the above particulars. This AB 64 was also forwarded to you but I note does not appear on list of effects on attached sheet.

An attempt at re-interment was made by Lt. Massey's party, but had to be abandoned in its initial stages owing to severe enemy shelling. Upon the burial party's return to the spot on the following day in order to complete the burial it was discovered that the ground had been greatly cut up by shell-fire and the body had completely disappeared.

There were no identification discs upon the body when found by Mr. Massey's party and it is opined that those were removed by the individuals who had originally interred the body.

No burial return was rendered by Mr. Massey, he apparently not considering it advisable under the circumstances as above stated.

Personally I do not think there is any doubt that the body was that of Pte Adams.
