



Private Israel Anthony Anderson (Regimental Number 1069) lies in Y Ravine Cemetery – Grave reference: Special Memorial C. 31.

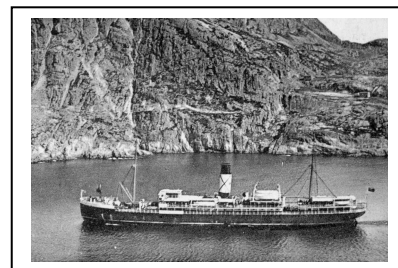
His occupation prior to his military service recorded as that of a *fisherman* earning an annual three-hundred dollars, Israel Anderson presented himself for enlistment at the *Church Lads Brigade Armoury* in St. John's, capital city of the Dominion of Newfoundland on January 20 of the year 1915.

Contrary to most of his fellow recruits, he was to undergo a medical examination *after* having enlisted; in his case, it came about two days later, on January 22, at the same *CLB Armoury* on Harvey Road. It was a procedure which would pronounce him to be...*Fit for Foreign Service*.

Israel Anderson was now to be obliged to wait for a further four weeks less a day before attestation, the final formality before becoming a soldier of the King. He took his oath of allegiance on February 18.

For Private Anderson, Number 1069, there was now to be yet another, but final, waiting period of some four weeks before he would be summoned to...*overseas service*. How he occupied himself during these two long periods is not recorded among his papers; he may, of course, have temporarily returned to work and, perhaps, to his home at Mouse Island near Channel on the west coast of the Island, but this is only speculation.

Unlike the two previous contingents to have departed Newfoundland (see below) for...*overseas service*, Private Anderson's 'D' Company was not to sail directly to the United Kingdom. On March 20 it, he a soldier of the Number 8 Platoon, embarked onto the Bowring-Brothers' vessel *Stephano* for the short voyage to Halifax, capital city of the Canadian province of Nova Scotia, where it was thereupon to board a second vessel, the newly-launched *Orduña* for the trans-Atlantic crossing*.

Having then sailed from Nova Scotia on March 22 for Liverpool, Private Anderson and his draft landed there eight days later, on the 30th. Once disembarked in Liverpool, the two-hundred fifty men and officers of 'D' Company were thereupon transported on the same date by train directly to Edinburgh, the Scottish capital, to join the Newfoundland Regiment's 'A', 'B' and 'C' Companies.

These units were by this time stationed at the historic Castle, 'A' and 'B' having recently been posted from Fort George and 'C' having arrived directly from home (see further below). After 'D' Company's arrival at the end of that month of March, the Newfoundlanders were now to remain at Edinburgh for the following six weeks.

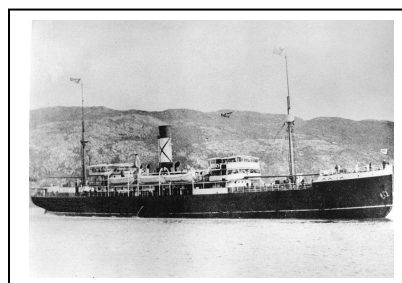

Five to six months before that time, in the late summer and early autumn of 1914 there had been a period of training of some five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits – these to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after a recruit's enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.



The ship had sailed for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1st Canadian Division overseas, off the south coast of the Island.

In the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the Salisbury Plain; then in Scotland at *Fort George* – on the Moray Firth close to Inverness; and lastly at Edinburgh Castle – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles.

Only days after 'A' and 'B' Companies had taken up their posting there, on February 16 'C' Company – the first re-enforcements for the original contingent* - would arrive directly from Newfoundland.

****This contingent, while a part of the Newfoundland Regiment, was not yet a battalion and would not be so for a further five months – as will be seen below.***

* * * * *

As seen in a previous paragraph, for the month of April and the first days of May of 1915, 'A', 'B', 'C' and 'D' Companies, now united, were to furnish the garrison – the first troops from outside the British Isles to do so - of the guardian of Scotland's capital city. Then,

during the first week of May, 'E' Company was to report there...*to duty*...from home. Four days later again, on May 11, the Newfoundland contingent was ordered elsewhere.

On that day, three weeks into spring – although in Scotland there was apparently still snow - the entire Newfoundland unit was dispatched to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

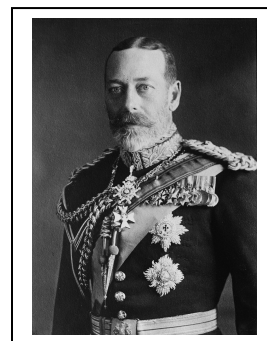
It was to be at *Stobs Camp* that the Newfoundland contingent would eventually receive the re-enforcements from home – 'F' Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength*. The now-formed 1st Battalion of the Newfoundland Regiment was thus rendered available to be sent on '*active service*'.

**This was approximately fifteen hundred, sufficient to furnish two re-enforcement companies and a headquarters staff.*

At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at Aldershot. This force, now the 1st Battalion of the Newfoundland Regiment, was thereupon attached to the 88th Brigade of the 29th Division of the (British) Mediterranean Expeditionary Force.



Meanwhile the two junior Companies, 'E' – last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming 2nd (Reserve) Battalion.

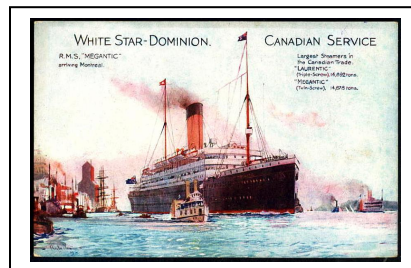
It was while the Newfoundland Battalion was in training during those weeks at Aldershot, on August 15 that Private Anderson would be prevailed upon to enlist for the duration of the conflict.

**At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist.*

On August 20, 1915, Private Anderson and his Newfoundland unit embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1st Battalion was to land at *Suvla Bay* on the *Gallipoli Peninsula*.

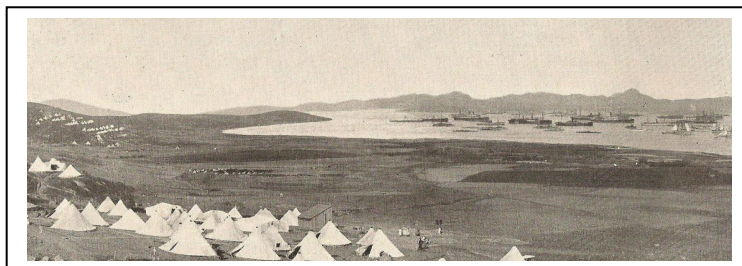

But Private Anderson was almost certainly not one of those who were to disembark on *Kangaroo Beach*. He had been taken sick during the voyage from Alexandria to *Suvla Bay* and thus was either evacuated from the ship during the Battalion's transfer onto the *Prince Abbas* at Mudros on the Greek island of Lemnos, or he was brought back from *Suvla Bay* to Mudros not having landed there, to be admitted on that September 20 into the 1st Stationary Hospital. He was suffering from chronic diarrhoea.

Only five days after his hospitalization, on September 26 Private Anderson was discharged from medical care and forwarded to *Convalescent Depot A. 36**.

**While it was likely established on Lemnos, the author has been unable to trace any further information of this facility.*

There is now no further trace to be found of him during the following five months, although it is likely that towards the end of this period he had been posted to the large British Base Depot of Sidi Bishr in Alexandria. However the next record of his movements to be found in his personal papers shows Private Anderson returning to the Newfoundland Battalion on March 1 of the following year, 1916.

By that time the unit had departed from the *Gallipoli Peninsula* to be encamped back in Egypt in the vicinity of Port Suez at the southern end of the canal of the same name.

* * * * *

When the Newfoundlanders had landed from their transport ship at *Suvla Bay* they would disembark into a campaign that was already on the threshold of collapse.

Not only in the area where the Newfoundland Battalion were to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had proved to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command* had ever anticipated – were eventually to overwhelm the British-led forces and those of the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

**Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.*

November 26 would see the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, were those afflicted by trench-foot and by frost-bite.

In the days which had followed that cataclysmic storm the British positions – and therefore those of the Newfoundlanders - were to become yet more and more untenable. On the night of December 19-20, the British had abandoned the area of *Suvla Bay* – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard.

Some of the Battalion personnel had thereupon been evacuated to the nearby island of *Imbros*, some to *Lemnos*, further away, but in neither case was the respite to be of a long duration; the 1st Battalion was to be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and *Anzac* forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – had now only been marking time until a complete withdrawal of the *Peninsula* could be undertaken.

This final operation would take place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

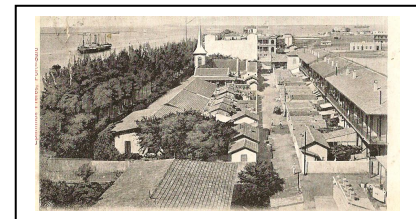

Immediately after the British had evacuated the entire *Gallipoli Peninsula* in January of 1916, the Newfoundland Battalion was to be ordered to the Egyptian port-city of Alexandria, to arrive there on the 15th of that month. The Newfoundlanders were then to be immediately transferred southward to the vicinity of Suez, a port at the southern end of the Canal, there to await further orders since, at the time, the subsequent destination of the British 29th Division had yet to be decided*.

And it was towards the end of the Newfoundland Battalion's posting to the camp at Suez the Private Anderson, likely having travelled from north to south down the length of the Suez Canal, reported there to his unit...*to duty...*on March 1, 1916.

Only days later he and the other Newfoundland personnel would be on the move once more, on this occasion to France and to the *Western Front*.

* * * * *

After their two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and *other ranks* of the 1st Battalion were to board His Majesty's Transport *Alaunia* at Port Tewfiq, on March 14 to begin the voyage up through the *Suez Canal* en route to France. The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseilles, on March 22.

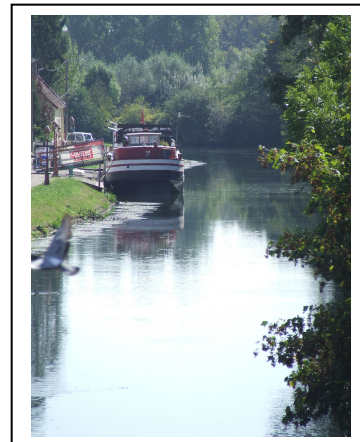
Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.

Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they then marched on their way from the station. But some three months later *the Somme* was to have become a part of their history.

On April 13, the 1st Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive reinforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the *Western Front*.



Just days following the Newfoundland Battalion's arrival on the *Western Front*, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit* before the entire Newfoundland unit was to then be ordered to move further up for the first time into forward positions on April 22.

**It should be said that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2nd Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.*

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, *the Somme*, that flowed – and still does so today – through the region.



At a personal level the month of May was marred by the loss of Private Anderson's gas-helmet (*gas-mask*) on the 4th while he and the Battalion were billeted at Mailly-Maillet. Despite this having been one of the few stains on his form book, he was nonetheless obliged to pay double its price as a penalty.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went *over the top* in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later*.

**Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.*

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been *killed in action or died of wounds*.

It was to be the largest disaster ever in the annals of the British Army...and, perhaps just as depressing, the butchery of *the Somme* was to continue for the next four and a half months.

In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.

The son of Joseph Anderson, fisherman, and of Jessie Anderson* – to whom he had allotted a daily allowance of 60 cents from his pay - of Mouse Island (off the coast of Channel, Port aux Basques), he was brother to Frederick, John, Alice, Charles, George, Ida-Catharine, Mary-Agnes and perhaps also to Jemima.

Private Anderson was at first reported as *missing in action* at Beaumont-Hamel on July 1, 1916, while serving with 'D' Company during the fighting of the first day of *the Somme*. Some six months later, on December 31, he was officially *presumed dead*.

However, subsequently, a burial report, dated April 23, 1917, was submitted by the General Officer Commanding 5th Corps, documenting his interment on that date in ground just to the west of the Y Ravine. Private Anderson's record was thus amended so as to read *killed in action*.

Israel Anthony Anderson had enlisted at the *declared* age of nineteen years: date of birth on Mouse Island, Channel, Newfoundland, March 18, 1896 (from the Newfoundland Birth Register in which is also found the name *Anthony*).

Private Israel Anthony Anderson was entitled to the 1914-1915 Star, as well as to the British War Medal (centre) and to the Victory Medal (Inter-Allied War Medal).
