

Private Peter Francis Bennett (Regimental Number 770), having no known last resting-place, is commemorated on the bronze beneath the Caribou in the Newfoundland Memorial Park at Beaumont-Hamel.



His occupation previous to military service recorded as that of a labourer working with Baine Johnson and Co. Ltd. of Water Street for a weekly wage of eight dollars, Peter Francis Bennett presented himself for medical examination on December 10, 1914, at the Church Lads Brigade Armoury on Harvey Road in St. John's, capital city of the Dominion of Newfoundland. It was a procedure which was to pronounce him as...Fit for Foreign Service. He was a recruit of the Second Draft.

Just six days after having undergone this medical appraisal, Peter Francis Bennett was to return to the *C.L.B. Armoury*, there to enlist – engaged at the private soldier's daily rate of a single dollar a day plus a ten-cent *Field Allowance*. It appears that he was also to attest on that same December 16.

Now for Private Bennett, Number 770, there was to be a seven-week waiting period. How he occupied himself during that period is not recorded among his papers; he may, of course, have temporarily returned to work but this is only speculation.

On the fourth day of February of 1915, the first reenforcements – this was 'C' Company - for the Newfoundland contingent – it was not yet at battalion strength - which by this time was serving in Scotland (see further below), were to embark via the sealing tender *Neptune* onto the SS *Dominion* – the vessel having anchored to the south of St. John's, off Bay Bulls, because of ice conditions.



The vessel was then to sail - and Private Bennett thus departed Newfoundland for *overseas service* - a day later again, on February 5, for trans-Atlantic passage to the United Kingdom.

\*There appears to be some confusion in some sources as to whether these troops were 'C' or 'D' Company. However, 'D' Company was to go overseas some time later on 'Stephano' to Halifax and then on 'Orduña' to Liverpool.

Having disembarked in the English west-coast port-city of Liverpool, the Newfoundlanders entrained for Edinburgh, the first Newfoundland Regiment contingent having by this time been posted to the historic Castle in Scotland's capital city. There they were to provide the garrison, thus being the first unit from overseas ever to do so.

Five to six months before that time, in the late summer and early autumn of 1914 there had been a period of training of some five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits - to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.



The ship would sail for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1<sup>st</sup> Canadian Division overseas, off the south coast of the Island.

In the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the Salisbury Plain; then in Scotland at *Fort George* – on the Moray Firth close to Inverness; and lastly at Edinburgh Castle – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles – and where 'C' Company and Private Bennett, as also cited beforehand, would arrive from Newfoundland on February 16 of 1915.

Some three months later, on May 11, and three weeks into spring – although in Scotland there was apparently still snow - the entire Newfoundland unit was ordered moved to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent received the reenforcements from home – 'F' Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength\*. The now-formed 1<sup>st</sup> Battalion of the Newfoundland Regiment was thus rendered eligible to be sent on 'active service'.

\*This was approximately fifteen hundred, sufficient to furnish two re-enforcement companies and a headquarters staff.

At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at Aldershot. This force, now the 1<sup>st</sup> Battalion of the Newfoundland Regiment, was thereupon attached to the 88<sup>th</sup> Brigade of the 29<sup>th</sup> Division of the (British) Mediterranean Expeditionary Force.

Meanwhile the two junior Companies, 'E' – last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming  $2^{nd}$  (*Reserve*) Battalion.

\*At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist.





On August 20, 1915, Private Bennett and the Newfoundland unit embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1<sup>st</sup> Battalion landed at *Suvla Bay* on the *Gallipoli Peninsula*.

When the Newfoundlanders landed from their transport ship at *Suvla Bay* on that September night of 1915 they were to disembark into a campaign that was already on the threshold of collapse.







Not only in the area where the Newfoundland Battalion was to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had proved to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command\* had ever anticipated – were eventually to overwhelm the British-led forces and those of the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

\*Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.

During the short period of three months which now followed, things were to worsen at *Gallipoli\** for the British in general and the 1<sup>st</sup> Battalion of the Newfoundland Regiment in particular.



\*The French know the place as 'Les Dardanelles' while the Turks call it 'Çanakkale'.

November 26 of 1915 would see perhaps the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, were those afflicted by trench-foot and by frost-bite.

As the days, weeks and months passed at *Suvla Bay*, the British position there was to become more and more untenable and thus on the night of December 19-20, they abandoned the area – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard.

Some of the Battalion personnel were to be evacuated to the nearby island of Imbros, some to Lemnos, further away; but in neither case would the respite be of a long duration; the 1<sup>st</sup> Battalion would be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and *Anzac* forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – were by now only marking time until a complete withdrawal of the *Peninsula* could be undertaken.

This final operation took place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

\*Lieutenant Owen Steele of St. John's, Newfoundland, is cited as having been the last soldier of the Mediterranean Expeditionary Force to step into the final small boat to sail from the Gallipoli Peninsula.

Immediately after the British evacuated the entire *Gallipoli Peninsula* in January of 1916, the Newfoundland Battalion was to be ordered to the Egyptian port-city of Alexandria, to arrive there on the 15<sup>th</sup> of that month. The Newfoundlanders would then immediately be transferred southward to the vicinity of Suez, a port at the southern end of the Canal which bears the same name, there to await further orders since, at the time, the subsequent destination of the British 29<sup>th</sup> Division had yet to be decided\*.



\*Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was soon to become a theatre of war.

It was during this period that Private Bennett was admitted into the  $17^{th}$  Stationary Hospital at Port Tewfiq – on February 12 – suffering from eczema. He was released from there to duty on March 14.

After a two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and other ranks of the 1<sup>st</sup> Battalion boarded His Majesty's Transport Alaunia at Port Tewfiq, on March 14 to begin the voyage through the Suez Canal en route to France. The Newfoundlanders would disembark eight days afterwards in the Mediterranean portcity of Marseilles, on March 22.





Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.




Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they then marched on their way from the station. But some three months later *the Somme* was to have become a part of their history.



On April 13, the 1<sup>st</sup> Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive reenforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the Western Front.

Familiarity with the trenches, however, was to come later for Private Bennett. On April 8, with 1<sup>st</sup> Battalion still in transit in the area of Louvencourt, he had been sent to the 29<sup>th</sup> Casualty Clearing Station at Gezaincourt for treatment to a sprained ankle. One week later, on the 15<sup>th</sup>, he was to be forwarded to the 2<sup>nd</sup> Canadian General Hospital in Le Tréport from where he was discharged *to duty* on April 22 – likely posted to the Base Depot at Rouen before re-joining the 1<sup>st</sup> Battalion in a re-enforcement draft at some unspecified later date\*.


\*Unfortunately, the Battalion War Diary appears not to record the arrival of many of the reenforcement drafts...to duty...with the unit. In fact, the amount of information to be gleaned from the journal on the majority of dates is all-too-often minimal.

Just days following the Battalion's arrival on the *Western Front* on April 13, now without Private Bennett, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit\* before the entire Newfoundland unit was then ordered to move further up for the first time into forward positions on April 22.

\*It should be said that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2<sup>nd</sup> Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, the Somme, that flowed – and still does so today – through the region.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went over the top in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later\*.

\*Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been killed in action or died of wounds.

It was to be the largest disaster ever in the annals of the British Army...and, perhaps just as depressing, the carnage of the Somme was to continue for the next four and a half months.

In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.

At Beaumont-Hamel Private Bennett was one of those wounded, having incurred gun-shot injuries to the left knee and thigh during the fighting of July 1, 1916, the first day of *First Somme*. He was evacuated to the 87<sup>th</sup> Field Ambulance – likely an advanced dressing station for which the field ambulances were normally responsible - from where, on the following day, he was forwarded to an unidentified casualty clearing station.

On the next day yet again, Private Bennett was on the move once more, on this occasion passing through the attentions of the 2<sup>nd</sup> General Hospital in Le Havre before being embarked onto His Majesty's Hospital Ship *Asturias* for the short cross-Channel passage en route back to the United Kingdom.

The Royal Mail Steam Packet Company vessel, built in 1908, was to be requisitioned as a hospital ship just prior to the onset of the Great War and was to serve as such until March of 1917 when she was torpedoed with some thirty-five lives lost. Her crew managed to beach her but, badly damaged, she was only to then be used for ammunition storage. In 1922 she was repaired to be used as a cruise ship in which capacity she served until 1930 when she was laid up and subsequently scrapped.

Upon his arrival in England, Private Bennett was admitted on July 5 into the 3<sup>rd</sup> London General Hospital in the Borough of Wandsworth where he was to remain for a week.

On July 12, Private Bennett was discharged from Wandsworth, having been granted the customary ten-day furlough accorded to military personnel upon release from hospital. Immediately after this period of leave, he was posted to the Regimental Depot where he reported to duty on July 21.

At the end of this summer of 1915, the once-Royal Borough of Ayr on Scotland's west coast was to begin to serve as the overseas base for the 2<sup>nd</sup> (*Reserve*) Battalion of the Newfoundland Regiment from where – as of November of 1915 and up until January of 1918 - re-enforcement drafts from home were to be despatched to bolster the 1<sup>st</sup> Battalion's numbers, at first to the Middle East and then later to the *Western Front*.

It was while he was at Ayr that Private Bennett's spotted past caught up with him and he was ordered to pay the price for four full charge sheets against him: he was thus awarded one-hundred sixty-eight days of detention plus the loss of twenty-seven days pay. Some of the time was apparently eventually remitted in order to allow him to return to active service on the Continent, but despite the imposed penalties, his later records do not show much marked improvement in his conduct.

On December 30 of 1916, the 16<sup>th</sup> Re-enforcement Draft, Private Bennett among that number, embarked in the English south-coast port of Southampton en route to the large British Expeditionary Base at Rouen, the capital city of Normandy. The contingent disembarked there on the following day, New Year's Eve, making its way to the Base for organizing and for final training\* before being ordered on to a rendezvous with 1<sup>st</sup> Battalion.

\*Apparently the standard length of time for this final training at the outset of the war had been ten days — although this was to become more and more flexible as the War progressed - in areas near Rouen, Étaples, LeHavre and Harfleur that became known notoriously to the troops as the Bull Rings.

During this short period spent at Rouen, Private Bennett was sent to the 2<sup>nd</sup> Convalescent Depot there on January 11, suffering from his old complaint, eczema. Discharged *to duty* to the 29<sup>th</sup> Divisional Base Depot on January 25, Private Bennett is recorded – in his own papers but not elsewhere - as having reported *to duty* with the 1<sup>st</sup> Battalion a month later, on February 27, on a day when the Regimental War Diary reports the Newfoundlanders as being out of the line with everyone having *a bath and trench-foot treatment*.

On the next day the Newfoundlanders were to move back into forward-area positions in the vicinity of the vestiges of the village of Sailly-Saillisel.

\* \* \* \* \*

In the meantime, after the events of the morning of July 1, 1916, and also after Private Bennett's departure for medical attention, such had then been the dire condition of the attacking British forces that it had been feared that a German counter-assault might well annihilate what had managed to survive of the British Expeditionary Force on the Somme.

The few remnants of the Newfoundland Battalion – and of the other depleted British units - had thus remained in the trenches perhaps fearing the worst, and at night searching for the wounded and burying the dead. It was to be July 6 before the Newfoundlanders were to be relieved from the forward area and to be ordered withdrawn to Englebelmer.



It had then been a further two days before the unit had marched further again to the rear area and to billets in the village of Mailly-Maillet.

There on July 11, a draft of one-hundred twenty-seven re-enforcements – a second source cites one-hundred thirty – had reported to duty. They had been the first to arrive following the events at Beaumont-Hamel but even with this additional man-power having arrived, the Regimental War Diary records that on the 14<sup>th</sup> of July, 1916, the 1<sup>st</sup> Battalion had still numbered only...11 officers and 260 rifles...after the holocaust of Beaumont-Hamel, just one-quarter of establishment battalion strength.

On July 27-28 of 1916, the 1<sup>st</sup> Battalion - still under establishment battalion strength at only five-hundred fifty-four strong, even after further re-enforcement – had moved north and entered into the *Kingdom of Belgium* for the first time.

It had been ordered to the *Ypres Salient*, one of the most dangerous pieces of real estate on the entire *Western Front*, there to continue to re-enforce and to re-organize after the ordeal of Beaumont-Hamel.

The Salient – close to the front lines for almost the entire fifty-two month conflict - was to be relatively quiet during the time of the Newfoundlanders' posting there; yet they nonetheless would incur casualties, a number – fifteen? - of them fatal.

Then on October 8, after having served in Belgium for some ten weeks, the Newfoundland Battalion had been ordered to return south, back into France and back into the area of – and the battle of – the Somme.

Four days after that return to France, on October 12, 1916, the 1<sup>st</sup> Battalion of the Newfoundland Regiment had again been ordered to the offensive; it was to be at a place called Gueudecourt, the vestiges of a village some dozen or so kilometres to the south-east of Beaumont-Hamel.

The encounter had proved to be another ill-conceived and costly affair – two hundred and thirty-nine casualties all told - for little gain.

The Newfoundland Battalion was not to be directly involved in any further concerted infantry action in the immediate area of Gueudecourt although, on October 18, it would supply two-hundred fifty men to act as stretcher-bearers in an attack undertaken by troops of two British regiments, the Hampshires and the Worcestershires, of the 88th Brigade.

On October 30, the Newfoundland unit had eventually been retired to rear positions from the Gueudecourt area. It had been serving in front-line and support positions for three weeks less a day.

The Newfoundlanders were now to spend two weeks withdrawn to the area of Ville-sous-Corbie, re-enforcing and reorganizing. It was not to be until November 15 that the 1<sup>st</sup> Battalion began to wend its way back up to the front lines.





There it continued its watch in and out of the trenches of the Somme – not without casualties – during the late fall and early winter, a period broken only by another several weeks spent in Corps Reserve during the Christmas period, encamped well behind the lines and in close proximity to the city of Amiens.

It had then been on January 11 that the Newfoundland Battalion was to be ordered out of Corps Reserve and its lodgings at *Camps en Amienois* from where it would make its way on foot to the community of Airaines. From the local railway station it had then been taken by train to the small town of Corbie where it had thereupon taken over billets which it had already occupied for a short period only two months before.

After that recent six-week Christmas respite spent in *Corps Reserve* far to the rear, the Newfoundlanders were to *officially* return to *active service* on January 23, although they apparently had already returned to the trenches by that date and had incurred their first casualties – and fatality – of 1917.

Those casualties, however, were only some of those everyday thousands whom Douglas Haig casually referred to as *wastage* as the Newfoundland unit had not ventured from its trenches.

In fact, the sole infantry activity *directly* involving the Newfoundland unit during that entire period – from Gueudecourt in mid-October, 1916, until Monchy-le-Preux in mid-April of 1917 – was to be the sharp engagement at Sailly-Saillisel at the end of February and the beginning of March, an action which would bring this episode in the Newfoundlanders' War – in the area of *the Somme* - to a close.

It was during this winter period, of course, but only some three days before the aforementioned action at Sailly-Saillisel, that Private Bennett had reported back to the Newfoundland Battalion.

After the confrontation at Sailly-Saillisel the month of March had been a quiet time for the Newfoundlanders; having departed from the trenches, they were now to spend their time near the communities of Meaulté and Camps-en-Amienois reenforcing, re-organizing, and in training for upcoming events. They had even had the pleasure of a visit from the Regimental Band, and also one from the Prime Minister of Newfoundland, Sir Edward Morris, the latter on March 17, St. Patrick's Day.

On March 29, the Newfoundlanders had begun to make their way – on foot – from Camps-en-Amienois to the north-east, towards the venerable medieval city of Arras and eventually beyond, the march to finish amid the rubble of the village of Monchy-le-Preux.

On April 9 the British Army was to launch an offensive in the area to the north of the Somme battlefields; this was to be the so-called Battle of Arras, intended to support a major French effort elsewhere. In terms of the daily count of casualties – just over four thousand - this attack was to be the most expensive operation of the Great War for the British, its only positive episode to be the Canadian assault of Vimy Ridge on the opening day of the battle, Easter Monday, 1917.



And while the British campaign would prove an overall disappointment, the French *Bataille du Chemin des Dames* had been yet a further disaster.

The 1<sup>st</sup> Battalion was to play its part during the *Battle of Arras*, a role that would begin at the place called Monchy-le-Preux on April 14 and which would finish ten days later, on April 23, perhaps a kilometre distant, at *Les Fosses Farm*. After Beaumont-Hamel, the ineptly-planned action at Monchy-le-Preux would prove to be the most costly day of the Newfoundlanders' war, four-hundred eighty-seven casualties all told on April 14 alone\*.

\*It was also an action in which a DSO, an MC and eight MMs were won by a small group of nine personnel of the Battalion – the Distinguished Service Order (DSO) awarded to the unit's Commanding officer. An MM for the same action was also presented to a private from the Essex Regiment.

The son of Joseph Bennett – wharfinger with *Baine Johnson Co. Ltd.*, and to whom he had willed his everything - and of Margaret Bennett (née *Olliver*) of 24, Feild Street in St. John's - his own address cited as 35, Wickford Street – he had allocated a daily sixty cents from his pay to a friend from work, Stan Cullen. He was also brother to Mary Jane and to Janet May one of whom was to pass away in or about 1919.

\*The couple married on September 12, 1891.

Private Bennett was reported as *missing in action* on April 14, 1917, while fighting at Monchy-le-Preux during the *Battle of Arras*. He was officially *presumed dead* on November 17, 1917, some thirty weeks later.



Peter Francis Bennett had enlisted at the *declared* age of twenty-one years: date of birth in St. John's, Newfoundland, November 14, 1893 (from the Newfoundland Birth Register).
