

Private George Augustus Brocklehurst (Regimental Number 848), having no known last resting-place, is commemorated on the bronze beneath the Caribou in the Newfoundland Memorial Park at Beaumont-Hamel.



His occupation previous to military service recorded as that of assistant messenger with the Colonial Secretary's Office - modestly perhaps, recording himself as a letter-carrier – and earning thirty-three dollars a month at the time, George Augustus Brocklehurst presented himself for medical examination at the Church Lads Brigade Armoury on Harvey Road in St. John's, capital city of the Dominion of Newfoundland on December 7, 1914. It was a procedure which was to pronounce him as...Fit for Foreign Service.

Twenty-three days following this medical assessment, on December 30, he then enlisted – engaged at the private soldier's rate of a single dollar per diem plus a daily ten-cent *Field Allowance*. However, whereas attestation for others had come about on the day of enlistment, George Brocklehurst was now to await a further two weeks, until January 14, before *that* final formality would come to pass.

Now for Private Brocklehurst, Number 848, there was to be a nine-week waiting period. How he occupied himself during that period is not recorded among his papers; he may, of course, have temporarily returned to work but this is only speculation.

Unlike the two previous contingents to have departed Newfoundland (see below) for...overseas service, Private Brocklehurst's 'D' Company was not to sail directly to the United Kingdom. On March 20, it embarked onto the Bowring-Brothers' vessel Stephano for the short voyage to Halifax, capital city of the Canadian province of Nova Scotia, where it was thereupon to board a second vessel, the newly-launched Orduña for the trans-Atlantic crossing\*.

Having then sailed from Nova Scotia on March 22 for Liverpool, Private Brocklehurst and his draft landed there eight days later, on the 30<sup>th</sup>. Once disembarked in Liverpool, the two-hundred fifty men and officers of 'D' Company were thereupon transported on the same date by train directly to Edinburgh, the Scottish capital, to join the Newfoundland Regiment's 'A', 'B' and 'C' Companies.

These units were by this time stationed at the historic Castle, 'A' and 'B' having recently been posted from Fort George and 'C' having arrived directly from home (see further below). After 'D' Company's arrival at the end of that month of March, the Newfoundlanders were now to remain at Edinburgh for the following six weeks.

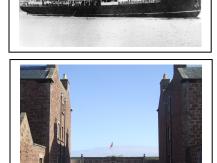
Five to six months before that time, in the late summer and early autumn of 1914 there had been a period of training of some five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits – these to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after a recruit's enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.

The ship had sailed for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1<sup>st</sup> Canadian Division overseas, off the south coast of the Island.

In the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern

England on the Salisbury Plain; then in Scotland at *Fort George* – on the Moray Firth close to Inverness; and lastly at Edinburgh Castle – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles.

Only days after 'A' and 'B' Companies had taken up their posting there, on February 16 'C' Company – the first re-enforcements for the original contingent\* - would arrive directly from Newfoundland.

\*This contingent, while a part of the Newfoundland Regiment, was not yet a battalion and would not be so for a further five months – as will be seen below.

\* \* \* \* \*

As seen in a previous paragraph, for the month of April and the first days of May of 1915, 'A', 'B', 'C' and 'D' Companies, now united, were to furnish the garrison – the first troops from outside the British Isles to do so - of the guardian of Scotland's capital city. Then, during the first week of May, 'E' Company was to report there...to duty...from home. Four days later again, on May 11, the Newfoundland contingent was ordered elsewhere.

On that day, three weeks into spring – although in Scotland there was apparently still snow - the entire Newfoundland unit was dispatched to *Stobs Camp*, all under canvas and southeastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent would eventually receive the re-enforcements from home – 'F' Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength\*. The nowformed 1<sup>st</sup> Battalion of the Newfoundland Regiment was thus rendered available to be sent on 'active service'.

\*This was approximately fifteen hundred, sufficient to furnish two re-enforcement companies and a headquarters staff.

At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at Aldershot. This force, now the 1<sup>st</sup> Battalion of the Newfoundland Regiment, was thereupon attached to the 88<sup>th</sup> Brigade of the 29<sup>th</sup> Division of the (British) Mediterranean Expeditionary Force.

Meanwhile the two junior Companies, 'E' – last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming  $2^{nd}$  (*Reserve*) Battalion.

It was while the Newfoundland Battalion was in training during those weeks at Aldershot, on August 15 that Private Brocklehurst would be prevailed upon to enlist for the duration of the conflict.

\*At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist.



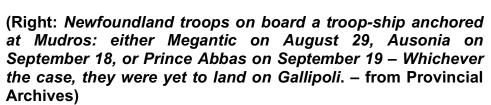

On August 20, 1915, Private Brocklehurst and his Newfoundland unit embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1<sup>st</sup> Battalion was to land at *Suvla Bay* on the *Gallipoli Peninsula*.

When the Newfoundlanders landed from their transport ship at *Suvla Bay* on that September night of 1915 they were to disembark into a campaign that was already on the threshold of collapse.



Not only in the area where the Newfoundland Battalion was to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, was proving to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command\* had ever anticipated – were eventually to overwhelm the British-led forces and those of the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

\*Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.



During the short three-month period which were now to follow, things were to worsen at *Gallipoli*\* for the British in general and for the 1<sup>st</sup> Battalion of the Newfoundland Regiment in particular.

\*The French know the place as 'Les Dardanelles' while the Turks call it 'Çanakkale'.

November 26 of 1915 would see perhaps the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods would wreak havoc amongst the forces of both sides. For several days, survival rather than the enemy became the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, were those afflicted by trench-foot and by frost-bite.

At *Suvla Bay*, the British positions were becoming more and more untenable and thus on the night of December 19-20, the area was to be abandoned – the Newfoundlanders, the only non-British unit serving there, to form a part of the rear-guard.

Some of the Battalion personnel were to be evacuated to the nearby island of Imbros, some to Lemnos, further away; but in neither case was the respite to be of a long duration; the 1<sup>st</sup> Battalion would be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and Anzac forces – the Australian and New Zealand Army Corps was also to serve at Gallipoli – were by that time only marking time until a complete withdrawal of the Peninsula could be undertaken.

This final operation took place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rearguard on this second occasion also.

\*Lieutenant Owen Steele of St. John's, Newfoundland, is cited as having been the last soldier of the Mediterranean Expeditionary Force to step into the final small boat to sail from the Gallipoli Peninsula.

Immediately after the British evacuated the entire *Gallipoli Peninsula* in January of 1916, the Newfoundland Battalion was to be ordered to the Egyptian port-city of Alexandria, to arrive there on the 15<sup>th</sup> of that month. The Newfoundlanders were then immediately to be transferred southward to the vicinity of Suez, a port at the southern end of the Canal which bears the same name, there to await further orders since, at the time, the subsequent destination of the British 29<sup>th</sup> Division had yet to be decided\*.





\*Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was soon to become a theatre of war.

After a two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and *other ranks* of the 1<sup>st</sup> Battalion boarded His Majesty's Transport *Alaunia* at Port Tewfiq, on March 14 to begin the voyage through the *Suez Canal* en route to France.

The Newfoundlanders would disembark eight days afterwards in the Mediterranean portcity of Marseilles, on March 22.

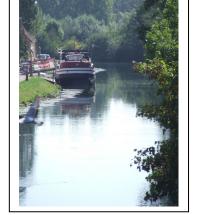

Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train would find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.



Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they then marched on their way from the station. But some three months later *the Somme* was to have become a part of their history.

On April 13, the 1<sup>st</sup> Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive re-enforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the *Western Front*.

Two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit\* before the entire Newfoundland unit was then ordered to move further up for the first time into forward positions on April 22.

\*It should be said that the Newfoundland unit and twohundred men of the Bermuda Rifles serving at the time in the 2<sup>nd</sup> Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, the Somme, that flowed – and still does so today – through the region.

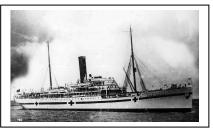

On June 5 of 1916, Private Brocklehurst was admitted into the 88<sup>th</sup> Field Ambulance whereupon he was diagnosed as suffering from pulmonary tuberculosis. On the same June 5, he was forwarded to the 4<sup>th</sup> Casualty Clearing Station at Lillers and from there on an unspecified date, to the 9<sup>th</sup> General Hospital at Rouen.

He was then evacuated back to the United Kingdom on board His Majesty's Hospital Ship *Dover Castle* from France on the 14<sup>th</sup> of that same month of June – another source says on the 11<sup>th</sup>, but this is perhaps unlikely given the date of his admission into hospital in England (see below).

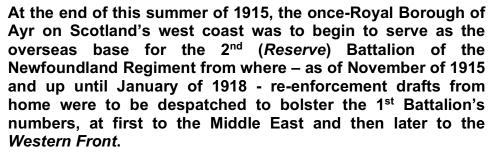
Upon arrival in England, Private Brocklehurst was reported as admitted into the 3<sup>rd</sup> London General Hospital in the Borough of Wandsworth on the 15<sup>th</sup>, where the previous diagnosis of tuberculosis was amended to the lesser one of bronchitis. Lammas Auxiliary Hospital (Esher Convalescent Home) was the next stop for Private Brocklehurst on July 5, the

diagnosis by then having been further reduced to that of bronchial catarrh. He was to remain there for just under three weeks.

On July 24 Private Brocklehurst was granted the customary ten-day furlough allowed those military personnel discharged from hospital care, before he was then immediately posted to the Regimental Depot at Ayr. There he reported...to duty...on August 2.

Some five months later, on December 30 of 1916, the 16<sup>th</sup> Reenforcement Draft from Ayr, Private Brocklehurst among its numbers, embarked in the English south-coast port of Southampton en route to the large British Expeditionary Base at Rouen, the capital city of Normandy. The contingent disembarked there on the 31<sup>st</sup>, New Year's Eve, then made its way to the Base for organizing and for final training\* before moving on to a rendezvous with the Newfoundland Battalion.

\*Apparently the standard length of time for this final training at the outset of the war had been ten days – although this was to become more and more flexible as the War progressed - in areas near Rouen, Étaples, LeHavre and Harfleur that became known notoriously to the troops as the Bull Rings.

Private Brocklehurst reported back...to duty...with the 1<sup>st</sup> Battalion at a camp just outside the community of Carnoy on January 17 of the New Year, 1917, the Regimental War Diarist recording...Draft of 51 O.R. arrived, chiefly wounded men returned. Beginning on the morrow, six of the next eleven days were to be spent in the trenches, but not by Private Brocklehurst: 'D' Company was apparently left behind when the others of the Newfoundland unit set out for a tour in the Flers trench system.

His return to his unit was not to be overly extended: only some two weeks later again, on the last day of that month of January, Private Brocklehurst was admitted into the 53<sup>rd</sup> Field Ambulance suffering from cystitis.

Apparently the complaint was not too serious: he was discharged back to duty on February 4.

\* \* \* \* \*

In the meantime, during Private Brocklehurst's absences, the Newfoundland Battalion was to play its part in two major confrontations with the enemy, engagements that were to weigh heavily on the small Dominion.

The first had been at a place called Beaumont-Hamel.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went over the top in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later\*.

\*Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.



There are other numbers of course: the fiftyseven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been killed in action or died of wounds.

It was to be the largest disaster ever in the annals of the British Army...and, perhaps just as depressing, the butchery of the Somme was to continue for the next four and a half months.

In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.

After the events of the morning of July 1, 1916, such had then been the dire condition of the attacking British forces that it had been feared that a German counter-assault might well annihilate what had managed to survive of the British Expeditionary Force on the Somme.

The few remnants of the Newfoundland Battalion – and of the other depleted British units - had thus remained in the trenches perhaps fearing the worst, and at night searching for the wounded and burying the dead. It was to be July 6 before the Newfoundlanders were to be relieved from the forward area and to be ordered withdrawn to Englebelmer.



It had then been a further two days before the unit had marched further again to the rear area and to billets in the village of Mailly-Maillet.

There on July 11, a draft of one-hundred twenty-seven re-enforcements – a second source cites one-hundred thirty – had reported to duty. They had been the first to arrive following the events at Beaumont-Hamel but even with this additional man-power having arrived, the Regimental War Diary records that on the 14<sup>th</sup> of July, 1916, the 1<sup>st</sup> Battalion still numbered only...11 officers and 260 rifles...after the holocaust of Beaumont-Hamel, just one-quarter of establishment battalion strength.

On July 27-28 of 1916, the 1<sup>st</sup> Battalion - still under establishment battalion strength at only five-hundred fifty-four strong, even after further re-enforcement – had moved north and entered into the *Kingdom of Belgium* for the first time.

It had been ordered to the *Ypres Salient*, one of the most dangerous pieces of real estate on the entire *Western Front*, there to continue to re-enforce and to re-organize after the ordeal of Beaumont-Hamel.

The Salient – close to the front lines for almost the entire fifty-two month conflict - was to be relatively quiet during the time of the Newfoundlanders' posting there; yet they had nonetheless incurred casualties, a number – fifteen? - of them fatal.

Then on October 8, after having served in Belgium for some ten weeks, the Newfoundland Battalion had been ordered to return south, back into France and back into the area of – and the battle of – the Somme.

Four days after that return to France, on October 12, 1916, the 1<sup>st</sup> Battalion of the Newfoundland Regiment had again been ordered to the offensive; it was to be at a place called Gueudecourt, the vestiges of a village some dozen or so kilometres to the south-east of Beaumont-Hamel.

The encounter would prove to be another ill-conceived and costly affair – two hundred and thirty-nine casualties all told - for little gain.

The Newfoundland Battalion was not to be directly involved in any further concerted infantry action in the immediate area of Gueudecourt although, on October 18, it would supply two-hundred fifty men to act as stretcher-bearers in an attack undertaken by troops of two British regiments, the Hampshires and the Worcestershires, of the 88th Brigade.

On October 30, the Newfoundland unit had eventually been retired to rear positions from the Gueudecourt area. It had been serving in front-line and support positions for three weeks less a day.

The Newfoundlanders were now to spend two weeks withdrawn to the area of Ville-sous-Corbie, re-enforcing and reorganizing. It was not to be until November 15 that the 1<sup>st</sup> Battalion had begun to wend its way back up to the front lines.





There it had continued its watch in and out of the trenches of the Somme – not without casualties – during the late fall and early winter, a period to be broken only by another several weeks spent in Corps Reserve during the Christmas period, encamped well behind the lines and in close proximity to the city of Amiens.

It had been on January 11 that the Newfoundland Battalion was to be ordered out of *Corps Reserve* and its lodgings at *Camps en Amienois* from where it would make its way on foot to the community of Airaines. From the railway station there it was to entrain for the small town of Corbie where it had thereupon taken over billets which it had already occupied for a short period only two months before.

From Corbie the unit had marched to Meaulté on January 16 where it had overnighted before moving on, on the morrow, to a camp in the vicinity of Carnoy. It had been there, as

cited in an above paragraph, that Private Brocklehurst had returned to the 1<sup>st</sup> Battalion, only to be hospitalized only two weeks afterwards.

After the recent six-week Christmas respite spent in *Corps Reserve* far to the rear, the Newfoundlanders, Private Brocklehurst once more among their ranks, were to *officially* return to *active service* on January 23, although they apparently had already returned to the trenches by that date and had incurred their first casualties – and fatality – of 1917.

Those casualties, however, were only some of the everyday thousands whom Douglas Haig casually referred to as *wastage* as during this time the Newfoundland unit had not ventured forward from its trenches.

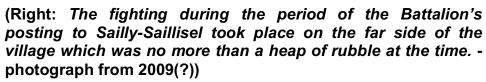

With Private Brocklehurst having returned on February 4 after that very brief second medical interlude, the sole infantry activity to *directly* involve the Newfoundland unit during that entire period – from Gueudecourt in mid-October, 1916, until Monchy-le-Preux in mid-April of 1917 – was now to be the sharp engagement at Sailly-Saillisel at the end of February and the beginning of March, an action which would bring this episode in the Newfoundlanders' War – in the area of *the Somme* - to a close.



What may have been Private Brocklehurst's role during those few days is not documented among his papers.

After Sailly-Saillisel the month of March was to be a quiet time for the Newfoundlanders; having departed from the trenches, they were now to spend their time near the communities of Meaulté and Camps-en-Amienois re-enforcing, re-organizing, and in training for upcoming events.

They were even to have the pleasure of a visit from the Regimental Band, and also one from the Prime Minister of Newfoundland, Sir Edward Morris, the latter on March 17, St. Patrick's Day.

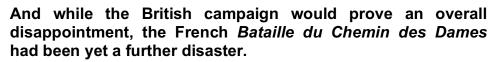
On March 29, the Newfoundlanders began to make their way – on foot – from Camps-en-Amienois to the north-east, towards the venerable medieval city of Arras and eventually beyond, the march to finish amid the rubble of the village of Monchyle-Preux.

On April 9 the British Army was to launch an offensive in the area to the north of the Somme battlefields; this was to be the so-called Battle of Arras, intended to support a major French effort elsewhere. In terms of the daily count of casualties – just over four thousand - this attack would be the most expensive operation of the Great War for the British, its only positive episode to be the Canadian assault of Vimy Ridge on the opening day of the battle, Easter Monday, 1917.

The 1<sup>st</sup> Battalion was to play its part during the *Battle of Arras*, a role that would begin at the place called Monchy-le-Preux on April 14 and which would finish ten days later, on April 23, perhaps a kilometre distant, at *Les Fosses Farm*. After Beaumont-Hamel, the ineptly-planned action at Monchy-le-Preux would prove to be the most costly day of the Newfoundlanders' war, four-hundred eighty-seven casualties all told on April 14 alone\*.

\*It was also an action in which a DSO, an MC and eight MMs were won by a small group of nine personnel of the Battalion – the Distinguished Service Order (DSO) awarded to the unit's Commanding officer. An MM for the same action was also presented to a private from the Essex Regiment.

After this further debacle the remnants of the Newfoundland Battalion remained in the area of Monchy-le-Preux. Its casualty count had been high enough to warrant that it and the Essex Regiment, which had also incurred heavy losses, be amalgamated into a composite battalion until such time as incoming re-enforcements would allow the two units' strengths to once more resemble those of bona fide battalions.

The final action in which the Newfoundland Battalion was to be involved during the five-week long *Battle of Arras* would be the engagement of April 23 at *Les Fosses Farm*. This was in fact an element of a larger offensive undertaken at the time by units of the British 5<sup>th</sup>, 3<sup>rd</sup> and 1<sup>st</sup> Armies. It was apparently not to be a particularly successful venture, at least not in the area of the 1<sup>st</sup> Battalion, several of the adjacent units reporting having been driven back by German counterattacks, actions accompanied by heavy losses.

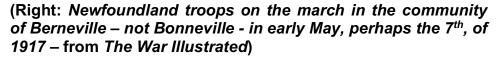


Late on that same evening the Newfoundlanders retired to the relative calm of Arras.

That month of May was to be a period when the Newfoundlanders would move hither and thither on the *Arras Front*, marching into and out of the trenches. While there was to be the ever-present artillery-fire, concerted infantry activity, particularly after May 15 – *officially* the last day of the *Battle of Arras* – would be limited, apart from the marching.







On the 10<sup>th</sup> day of that month of May, 1917, Private Brocklehurst was once more in need of medical attention. On this occasion it was for ICT (*Inflammation of the Connective Tissues*) of the fingers, for which he was admitted at first into the 63<sup>rd</sup> (*1/1 London*) Casualty Clearing Station at Boubers sur Canche and then passed on to the 37<sup>th</sup> CCS, probably established at Avesnes by that time.

Private Brocklehurst was to continue receiving treatment for the best part of a month before being released from care. He reported back to the 1<sup>st</sup> Battalion on June 7.

\* \* \* \* \*

At the outset of June, the Newfoundland unit had retired from the line to Bonneville, there to spend its time again re-enforcing, re-organizing and in training for the upcoming British offensive of the summer – and as it transpired, the autumn as well. The re-enforcement draft which arrived on that June 7 – including Private Brocklehurst – comprised fourteen officers and ninety-two other ranks.

Twenty days later, the Newfoundlanders were, for the second time, on their way north into Belgium - and once again into the vicinity of Ypres and...the Salient, their first posting to be to the banks of the Yser Canal just to the north of the city.

This low-lying area, Belgian *Flanders*, the only part of the country unoccupied by German forces, had been selected by the High Command to be the theatre of the British summer offensive of 1917.

Officially designated as the *Third Battle of Ypres*, the campaign was to come to be better known to history simply as *Passchendaele*, having adopted that name from a small village on a not-very high ridge to the north-east that later was to be cited as having been – *ostensibly* - one of the British Army's objectives.

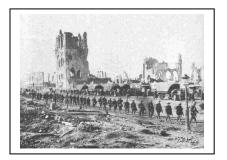

Having arrived in Belgium, Private Brocklehurst was to be absent from the 1<sup>st</sup> Battalion for two weeks. On July 5 according to the Battalion War Diary – July 7 according to his personal record – he and twenty-six *other ranks* plus one officer were seconded to the 173<sup>rd</sup> Tunnelling Company of the Royal Engineers until July 21; the reason is not cited.

They returned to the 1st Battalion on that latter date having suffered no casualties.

The 1<sup>st</sup> Battalion of the Newfoundland Regiment was to remain in Belgium until October 17, a small cog in the machinery of the British Army. This had been or was also to be the case with the Australians, the New Zealanders and the Canadians, all of whose troops had floundered or would soon flounder their way across the sodden and shell-torn countryside of Belgian Flanders.

Notably the Newfoundland Battalion at *Passchendaele* was to fight in two major engagements: at the *Steenbeek* on August 16; and at the *Broembeek* (see both immediately below) on October 9. At the former it had incurred nine *killed in action*, ninety-three wounded, and one missing in action; at the *Broembeek* the cost had been higher: forty-eight killed or died of wounds, one-hundred thirty-two wounded and fifteen missing in action.

The Steenbeek is one of those innocuous ditched brooks which criss-cross the flat Flemish countryside at numerous intervals. On August 16<sup>th</sup>, 1917, it served to mark the boundary of the Newfoundland Battalion's objective(s) of the day and that - or those - of another unit.

That day was to see another of those seemingly endless costly offensive actions of the battle which gained a few metres of soup-like ground – and lost a goodly number of lives.

The son of Charles Joseph Frederick Brocklehurst, also a messenger at the *Colonial Secretary's Office* – to whom he had allotted an allowance of sixty cents a day from his pay and to whom he had willed his all - and of Mary Ann Brocklehurst (née *Dunne* – also found as Dunn - deceased on November 1, 1904)\* of 21, Maxse Street in St. John's, he was brother to sisters Kate, Lilian, Elizabeth-Julia and Mary-Jane (deceased aged eleven circa 1894), and to brothers Samuel-Stephen, Edwin-Joseph, John-Thomas, Charles-Francis and Edward-Stanislaus (see below\*\*).

<sup>\*</sup>The couple had married on July 15, 1877.

Private Brocklehurst was reported as having been *killed in action* on August 16, 1917, while serving with 'D' Company during the fighting at the *Steenbeek*.

George Augustus Brocklehurst had enlisted at a *declared* twenty-seven years of age: date of birth in St. John's, Newfoundland, July 14, 1887 (from Roman Catholic Parish Records).

\*\*The youngest brother, Edward-Stanislaus, also served in the Newfoundland Regiment (Private, Number 2519); two others, John-Thomas and Samuel-Stephen, were soldiers with the Canadian Expeditionary Force. All three survived the War. A family source records there having been seven brothers altogether – including George. Two others appear to remain to be found.

Private George Augustus Brocklehurst was entitled to the 1914-1915 Star, as well as to the British War Medal (centre) and to the Victory Medal (Inter-Allied War Medal) (right).
