



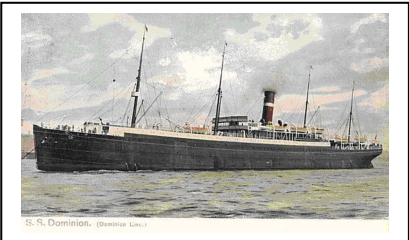
Private Michael Broderick (Regimental Number 808) is interred in Gezaincourt Communal Cemetery Extension – Grave reference I. G. 13.

His occupation previous to military service recorded as that of a fisherman earning \$500.00 per annum, Michael Broderick presented himself for medical examination on December 23, 1914, at the *Church Lads Brigade Armoury* on Harvey Road in St. John’s, capital city of the Dominion of Newfoundland. It was a procedure which was to pronounce him as...*Fit for Foreign Service*. He was a recruit of the Second Draft.

Just three days – one of them having been Christmas Day, after having undergone this medical assessment, Michael Broderick was to return to the *C.L.B. Armoury*, there to enlist – engaged at the private soldier’s daily rate of a single dollar a day plus a ten-cent *Field Allowance*. It appears that he was also to attest on that same Boxing Day, December 26.

While those recruits of the Second Draft and resident in St. John's were to spend the next number of weeks at home, often continuing, at least temporarily, to work, those from further afield were often lodged in the city, the expenses coming from the Public Purse. Private Broderick, Number 808, from St. Brendan's, was apparently to stay at the home of Mr. and Mrs. P. Murphy – were they his aunt and uncle? - on Long's Hill, although how he was to occupy himself during those six weeks is not to be found among his papers.

On the fourth day of February of 1915, the first reinforcements – this was 'C' Company - for the Newfoundland contingent – it was not yet at battalion strength - which by this time was serving in Scotland (see further below), were to embark via the sealing tender *Neptune* onto the SS *Dominion* – the vessel having anchored to the south of St. John's, off Bay Bulls, because of ice conditions.



The vessel was then to sail - and Private Broderick thus departed Newfoundland for overseas service - a day later again, on February 5, for trans-Atlantic passage to the United Kingdom.

**There appears to be some confusion in some sources as to whether these troops were 'C' or 'D' Company. However, 'D' Company was to go overseas some time later on 'Stephano' to Halifax and then on 'Orduña' to Liverpool.*

Having disembarked in the English west-coast port-city of Liverpool, the Newfoundlanders entrained for Edinburgh, the first Newfoundland Regiment contingent having by this time been posted to the historic Castle in Scotland's capital city. There they were to provide the garrison, thus being the first unit from overseas ever to do so.



Private Broderick and the other new-comers reported to duty at Edinburgh Castle on February 16.

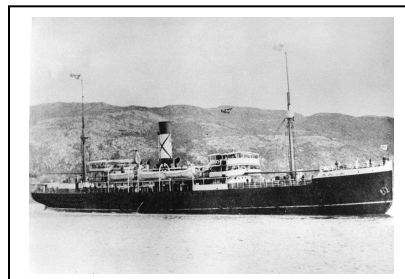

Five to six months before that time, in the late summer and early autumn of 1914 there had been a period of training of some five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits - to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.



The ship would sail for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1st Canadian Division overseas, off the south coast of the Island.

In the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the Salisbury Plain; then in Scotland at *Fort George* – on the Moray Firth close to Inverness; and lastly at Edinburgh Castle – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles – and where 'C' Company and Private Broderick, as also cited beforehand, would arrive from Newfoundland on February 16 of 1915.

* * * * *

Some three months later, on May 11, and three weeks into spring – although in Scotland there was apparently still snow - the entire Newfoundland unit was ordered moved to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent received the reinforcements from home – 'F' Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength*. The now-formed 1st Battalion of the Newfoundland Regiment was thus rendered eligible to be sent on 'active service'.

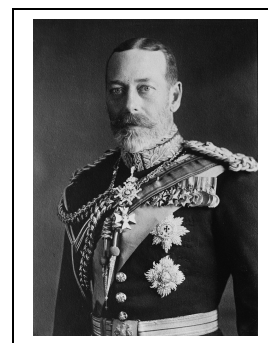


****This was approximately fifteen hundred, sufficient to furnish four 'fighting' companies, two re-enforcement companies and a headquarters staff.***

At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at Aldershot. This force, now the 1st Battalion of the Newfoundland Regiment, was thereupon attached to the 88th Brigade of the 29th Division of the (British) Mediterranean Expeditionary Force.

Meanwhile the two junior Companies, 'E' – last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming 2nd (Reserve) Battalion.

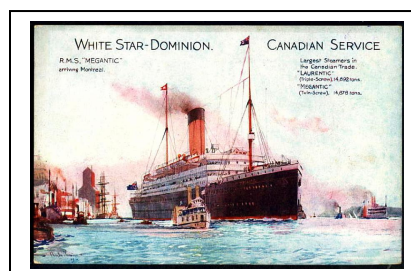


It was during this period at Aldershot, on August 15, that Private Broderick was prevailed upon to re-enlist, on this occasion for the *duration of the war.**

****At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist.***

On August 20, 1915, Private Broderick and the Newfoundland unit embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1st Battalion landed at *Suvla Bay* on the *Gallipoli Peninsula*.

When the Newfoundlanders landed from their transport ship at *Suvla Bay* on that September night of 1915 they were to disembark into a campaign that was already on the threshold of collapse.

Not only in the area where the Newfoundland Battalion was to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had proved to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command* had ever anticipated – were eventually to overwhelm the British-led forces and those of the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

**Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.*

During the short period which now followed, things were to worsen at *Gallipoli** for the British in general and for the 1st Battalion of the Newfoundland Regiment in particular.

November 26 of 1915 would see perhaps the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, were those afflicted by trench-foot and by frost-bite.

* * * * *

Three short days after the aforementioned catastrophic storm, on November 29 Private Broderick was evacuated from the Newfoundland positions back to the 26th Casualty Clearing Station at *Suvla Bay*, diagnosed as suffering from jaundice and a severe case of dysentery. Soon transferred – possibly via the Greek island of Lemnos - onto His Majesty's Hospital Ship *Rewa*, he was transported to the British-held Mediterranean island of Malta and to St. George's Hospital there, where he was admitted on December 4.

However, on January 4 of 1918, while en route from Malta to Great Britain, she was torpedoed. Fortunately it was to take two hours for her to sink, this allowing all wounded – two-hundred seventy-nine – medical staff and crew – except for four Indian members working in the engine room at the time of the explosion.*)

Reported as still recovering from dysentery on Malta in early April of the following year, 1916 - having been convalescent at *All Saints' Camp* from December 21 until sent to St. Barnabas' Hospital at Ghain Tuffieha on April 5 – Private Broderick was discharged *to duty* on the 29th of that same month and thereupon ordered transported to the British Base Depot at Sidi Bishr, Alexandria, on board His Majesty's Transport *Transylvania*.

In Alexandria for only a matter of days, he embarked there for passage to the French Mediterranean port of Marseilles on May 8, arriving at his destination on the 16th. Private Broderick is next recorded as having reported *to duty* with the 1st Battalion on June 9 – probably via the British Base Depot at Rouen to join a re-enforcement draft - while the Newfoundlanders were in billets at Louvencourt, several kilometres behind the lines.

* * * * *

In the meantime, at *Suvla Bay* after Private Broderick's departure to Malta for medical attention, the British positions were to be becoming more and more untenable and thus on the night of December 19-20, the area had been abandoned – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard.



Some of the Battalion personnel were to be evacuated to the nearby island of Imbros, some to Lemnos, further away; but in neither case had the respite been of a long duration; the Newfoundland Battalion would be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and Anzac forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – had by then only been marking time until a complete withdrawal of the *Peninsula* could be undertaken.

This final operation had taken place on the night of January 8-9, the Newfoundland Battalion to furnish a part of the British rear-guard on this second occasion also.

**Lieutenant Owen Steele of St. John's, Newfoundland, is cited as having been the last soldier of the Mediterranean Expeditionary Force to step into the final small boat to sail from the Gallipoli Peninsula.*

Immediately after the British had evacuated the entire *Gallipoli Peninsula* in January of 1916, the Newfoundland Battalion was to be ordered to the Egyptian port-city of Alexandria, to arrive there on the 15th of that month. The Newfoundlanders had then immediately been ordered transferred southward to the vicinity of Suez, a port at the southern end of the Canal which bears the same name, there to await further orders since, at the time, the subsequent destination of the British 29th Division had yet to be decided*.

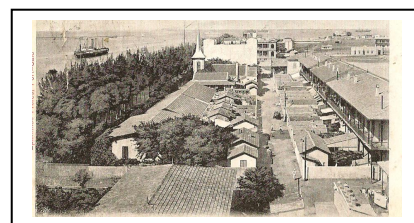

After a two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and *other ranks* of the 1st Battalion boarded His Majesty's Transport *Alaunia* at Port Tewfiq, on March 14 to begin the voyage through the *Suez Canal* en route to France.



The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseilles, on March 22.

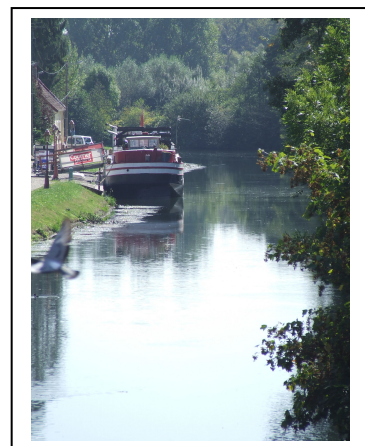
Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.



Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they then marched on their way from the station. But some three months later *the Somme* was to have become a part of their history.

On April 13, the 1st Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive re-enforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the *Western Front*.

Just days following the Newfoundland Battalion's arrival on the *Western Front*, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit* before the entire Newfoundland unit was then ordered to move further up for the first time into forward positions on April 22.

**It should be said that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2nd Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.*

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, *the Somme*, that flowed – and still does so today – through the region.

And it was on or about June 9, during this period, that Private Broderick, as cited in a previous paragraph, would report...to *duty*...to the Newfoundland Battalion while it was billeted at Louvencourt.

* * * * *

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went *over the top* in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later*.

**Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.*

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been *killed in action or died of wounds*.

It was to be the largest disaster ever in the annals of the British Army...and, perhaps just as depressing, the futile carnage of *the Somme* was to continue for the next four and a half months.

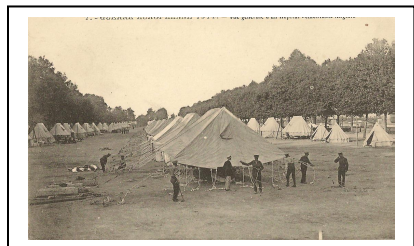
In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.

The son of Patrick Broderick, fisherman, and of Catherine Broderick (née Lane, deceased on November 9, 1921) of St. Brendan's, he was brother of Elizabeth-Ann and perhaps John-Thomas, as well as being the nephew of Anastasia Murphy of 38, Young Street in St. John's, to whom he had allotted an allowance of fifty cents per day from his pay.

Private Broderick was reported as having *died of wounds* on July 3, 1916, succumbing to gun-shot injuries incurred at Beaumont-Hamel on July 1 while serving with 'C' Company during the fighting of the first day of *the Somme*. He had been admitted to 29th Casualty Clearing Station at Gezaincourt on July 2, and passed away there on the following day.

At home it was the Reverend J. Mackay who was requested to bear the news to his family.

Michael Broderick had enlisted at a *declared* twenty-two years of age.
