



Seaman Albert James Warren, Number 2179x, having no known last resting-place, is commemorated on a bronze beneath the Caribou at the Newfoundland Memorial Park at Beaumont-Hamel.

Having decided to *answer the call* of the naval authorities for volunteers, Albert James Warren travelled from the District of Bonavista to St. John's, capital city of the Dominion of Newfoundland where, on November 4-5 of 1914, he reported...*to duty*...on the Naval Reserve training ship, HMS *Calypso*, moored in the harbour (see below).



On that early November day he enlisted into the Naval Reserve for a first time (see further below), signing to serve for just a single year's* war-time service and likely undergoing the required medical assessment on or about the same date. He also likely attested at this time, pledging his allegiance to the King-Emperor, George V.

***In the early days of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist. Later recruits – as of or about May of 1916 - signed on for the 'Duration' at the time of their original enlistment.**



(Right above: The White Ensign has been flown by the Royal Navy in its present form since about the year 1800 although other naval ensigns had existed for at least two centuries. It consists of a red St. George's Cross – the national flag of England - on a white field with the Union Flag* in the upper canton.)

***The Union Flag is commonly referred to as the 'Union Jack'; this is, in fact, a misnomer since a flag is referred to as a 'Jack' only when flown from the bow of a ship.**

Note: During the years preceding the Great War the only military force on the Island of Newfoundland – apart from a handful of ill-fated local attempts – was to be the Royal Naval Reserve (Newfoundland). Even so, it was to be some thirty years after the withdrawal of British troops from the Dominion in 1870 before the Reserve came into being in 1902.



Just fewer than four-hundred men were sought to enroll as seamen – apparently automatically at the rank of Able Seaman - and to present themselves annually in St. John's for five years in order to train for a period of twenty-eight days per annum. Allowed to report at a time of their own choosing, it is perhaps not surprising that these volunteers – mostly fishermen – were to opt to train during the winter months when fishing work was minimal.

Expenses were apparently defrayed for the most part by the British (Imperial) Government and an attempt was made to ensure the number of recruits would be kept constantly at a maximum. This practice and policy was then to be continued up until the onset of hostilities some twelve years later.

Of course, the purpose of having a reserve force at any time is to provide a trained force ready at any time to serve at a time of need or crisis. Thus in August of 1914, upon the Declaration of War by the government in London, hundreds of those men of the Royal Naval Reserve (Newfoundland) were to make their way to St. John's, from there to take passage overseas to bolster the ranks of the Royal Navy.

An elderly vessel, HMS 'Calypso', having become surplus to the Admiralty's needs, had been provided to the Dominion of Newfoundland by the Royal Navy in 1902 for training purposes. After some debate it was eventually decided that she would be permanently moored in the harbour of the capital, her superstructure reduced, and a wooden shelter built on her upper deck to provide training facilities and living quarters for the prospective naval recruits.

Following only some two weeks of training* in St. John's, Seaman Warren, one of a draft of one-hundred forty-nine naval reservists, embarked on November 18-19 onto the Allan Line ocean-liner *Carthaginian* which was apparently returning on its commercial route from Philadelphia(?) to Glasgow and thereupon took the draft on board. She sailed at nine o'clock in the evening of the 19th, its reservist passengers un-mentioned in the local newspapers.

**It appears that in many cases, even if the recruit in question had not already previously been with the Royal Naval Reserve, the required twenty-eight day training period, all or partially, was waived by 'Royal Proclamation'.*

Once having disembarked in the United Kingdom it appears that while some few of the men were posted directly to a ship, the majority was ordered directly to proceed to one of various Royal Navy establishments and thus, likely having journeyed by train, reported to these bases on or about November 28-29.

It appears that Seaman Warren was one of those ordered to immediately join his ship, HMS *Viknor*, which was apparently at the time based on the River Tyne in north-east England. She was not to leave port until December 28 and not to join her squadron (see below) until January 1.

The Armed Merchant Cruiser *Viknor* was an elderly ship, obsolete and apparently under-powered with a top speed of only fourteen knots. In her earlier lives she had firstly been, as of 1888, the SS *Atrato*, before then having been re-named as the SS *Viking* in 1912. Upon the outbreak of the *Great War* in 1914 she had been requisitioned by the British Admiralty and baptized on a third occasion as HMS *Viknor*.

'*Viknor*' was to be attached to the 10th Cruiser Squadron, also known as the *Northern Patrol*, a force originally having comprised out-of-date warships which, by that January of 1915, had been replaced by requisitioned ocean-going passenger-liners fitted with guns, some as elderly as a number of the venerable ships on which they were mounted.

The ships of the 10th Cruiser Squadron were not spoiling for a fight. Their job was to form a part of the naval blockade designed to prevent ships carrying goods to Germany from reaching their destination; to accomplish this these vessels had to patrol the area of stormy waters encompassed by Ireland, northern Scotland and Iceland, a thankless job at the best of times: during the tempestuous winter months, even worse.

In early January the ships of the *Northern Patrol* stopped a Norwegian vessel, the *Bergensfjord*, and transferred a number of persons, one of them a suspected spy, to *Viknor*, she then being ordered to proceed to Liverpool.

From what is known about *Viknor*, she was hardly a vessel fit for the task at hand and January and February of 1915 were to apparently be particularly stormy. What is more, a German counterpart, the steamship *Berlin*, had recently been reported in the area sowing mines – one of which had already sunk the British battleship *Audacious* some three months before.



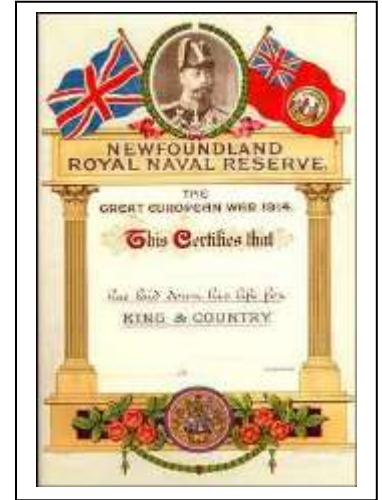

Thus it still remains a bit of a mystery as to what happened to *Viknor* although it appears to be that either she fell victim to the bad weather or that she was sunk by a mine. All that may be sent with any great certainty is that there was not to be a single survivor: of the crew of three-hundred two, including twenty-five of the Royal Naval Reserve (Newfoundland), all were to perish*.

**Her wreck was found off the coast of County Donegal, Ireland, in the year 2006, but no firm conclusion was to come about as to the cause of the ship's sinking.*

The son Eli Warren and of Mary-Ann Warren (née *Cheater**) of the Gooseberry Islands before the community of Glovertown, Alexander Bay, Albert-James Warren was also brother to Annie-Esther, Nathan-Samuel, Arthur-W.*, Baxter and to Edgar-Kenneth.

**The couple had been married in the Bonavista community of Greenspond on November 30 of 1882.*

Seaman Warren died on January 13 of 1915 at the recorded age of twenty-two years: date of birth on the Gooseberry Islands, Newfoundland, September 20, 1893 (from Newfoundland Vital Statistics and his Service Record), but also July 19, 1892 (from the 1911 Census).

Seaman Warren served only in the Royal Navy and was not in the service of Canada as is cited in some sources, notably the Commonwealth War Graves Commission.

Seaman Albert James Warren was entitled to the 1914-1915 Star, to the British War Medal (centre) and to the Victory Medal (Inter-Allied War Medal).

****His older brother Arthur had been a sailor of the Royal Naval Reserve (Newfoundland) since the end of the year 1912, having enlisted on December 28 of that year and undergone a satisfactory medical assessment on the same day. He almost certainly then was to complete a required twenty-eight day course of training.***

Having been then summoned to war-time service, Seaman Arthur Warren reported to HMS 'Calypso' on December 16 of 1914, and proceeded to overseas service on the morrow on board the SS 'Mongolian'.

Having been ordered to HMS 'Victory I'* upon his arrival in the United Kingdom he was likely sent to the holding-barracks although by that time he must have been starting to show the symptoms of a medical problem.

****Not a ship although named for one, Seaman Warren's HMS 'Victory' was a land-based training establishment in the naval port-city of Portsmouth on the south coast of England. It was also a holding-barracks for seamen posted there to await a summons to serve on one of His Majesty's ships.***

There was apparently to be no ship. On February 18 of 1915 he was transferred back to the nominal roll of HMS 'Calypso' from where, two weeks less a day later, he was discharged as being...medically unfit...due to a case of pulmonary tuberculosis, but he was to make a recovery and to live until the age of eighty. However, the details of his repatriation – except that by early 1916 he had returned to Newfoundland - have proved to be elusive.

Seaman Arthur Warren was already married by the time of his enlistment - the couple having wedded in Glovertown on February 11 of 1911 - to Hannah (also found as Annie) Taylor. The couple was to parent four children.
