

Private Edward Rozier Winter (Regimental Number 675) lies in Ancre British Cemetery – Grave reference II. B. 9.

His occupation previous to military service recorded as that of a *clerk* earning three dollars a week, Edward Rozier Winter presented himself for medical examination on November 30, 1914, at the *Church Lads Brigade Armoury* on Harvey Road in St. John's, capital city of the Dominion of Newfoundland. It was a procedure which was to pronounce him as...*Fit for Foreign Service*. He was a recruit of the Second Draft.

Two weeks plus a single day later, Edward Winter was to return to the *C.L.B. Armoury*, there to enlist – engaged at the private soldier's daily rate of a single dollar a day plus a ten-cent *Field Allowance*. It appears that he also attested on that same December 15.

Now for Private Winter, Number 675, there was to be a seven-week waiting period.

On the fourth day of February of 1915, the first reenforcements – this was 'C' Company - for the Newfoundland contingent – it was not yet at Battalion strength - which by this time was serving in Scotland (see further below), were to embark via the sealing tender *Neptune* onto the SS *Dominion* – the vessel having anchored to the south of St. John's, off Bay Bulls, because of ice conditions.



The vessel was then to sail - and Private Winter thus departed Newfoundland for *overseas service* - a day later again, on February 5, for trans-Atlantic passage to the United Kingdom.

\*There appears to be some confusion in some sources as to whether these troops were 'C' or 'D' Company. However, 'D' Company was to go overseas some time later on 'Stephano' to Halifax and then on 'Orduña' to Liverpool.

Having disembarked in the English west-coast port-city of Liverpool, the Newfoundlanders entrained for Edinburgh, the first Newfoundland Regiment contingent having by this time been posted to the historic Castle in Scotland's capital city. There they were to provide the garrison, thus being the first unit from overseas ever to do so.

Private Winter and the other new-comers reported to duty at Edinburgh Castle on February 16.

Five to six months before that time, in the late summer and early autumn of 1914 there had been a period of training of some five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits - to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.

The ship would sail for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1<sup>st</sup> Canadian Division overseas, off the south coast of the Island.

In the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the Salisbury Plain; then in Scotland at *Fort George* – on the Moray Firth close to Inverness; and lastly at Edinburgh Castle – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles – and where 'C' Company and Private Winter, as also cited beforehand, would arrive from Newfoundland on February 16 of 1915.

Some three months later, on May 11, and three weeks into spring – although in Scotland there was apparently still snow - the entire Newfoundlanders unit was ordered moved to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent received the reenforcements from home – 'F' Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength\*. The now-formed 1<sup>st</sup> Battalion of the Newfoundland Regiment was thus rendered eligible to be sent on 'active service'.

\*This was approximately fifteen hundred, sufficient to furnish four 'fighting' companies, two re-enforcement companies and a headquarters staff.


At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at Aldershot. This force, now the 1<sup>st</sup> Battalion of the Newfoundland Regiment, was thereupon attached to the 88<sup>th</sup> Brigade of the 29<sup>th</sup> Division of the (British) Mediterranean Expeditionary Force.

Meanwhile the two junior Companies, 'E' – last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming  $2^{nd}$  (*Reserve*) Battalion.

Private Winter, however, was to be occupied otherwise during much of this time: he had incurred a venereal problem and was to be hospitalized – in four different institutions - for almost exactly three months. After stays for treatment, beginning on July 7, at Edinburgh, Glencorse, Newcastle-on-Tyne and finally Glasgow, he was released on October 8 and posted to the new Regimental Depot.

At the end of that summer of 1915, the once-Royal Borough of Ayr on Scotland's west coast was to begin to serve as the overseas base for the 2<sup>nd</sup> (*Reserve*) Battalion of the Newfoundland Regiment from where – as of November of 1915 and up until January of 1918 - re-enforcement drafts from home were to be despatched to bolster the 1<sup>st</sup> Battalion's numbers, at first to the Middle East and then later to the *Western Front*.

It would have been during this period spent in Scotland that Private Winter was most likely prevailed upon to re-enlist *for the duration of the war\** – as many others were – on or about October 1.

\*At the outset of hostilities, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist.

On November 14, 1915, Private Winter was to embark with the 1<sup>st</sup> Re-enforcement Draft from Ayr in the naval harbour of Devonport onto the liner-converted-to-transport-ship *Olympic*, sister ship of *Britannic* and *Titanic*, en route for the Middle East and for the fighting in *Gallipoli*. There, on December 1, having been transferred to a smaller craft, he disembarked with re-enforcements at *Suvla Bay*.



Private Winter – and the other re-enforcements – were to serve there for a bare three weeks.

When the Newfoundlanders landed from their transport ship at *Suvla Bay* on that December 1 of 1915 they were to disembark into a campaign that was already on the threshold of collapse.

Not only in the area where the Newfoundland Battalion was to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had proved to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command\* had ever anticipated – were eventually to overwhelm the British-led forces and those of the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

\*Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Gallipoli Campaign\* and had just gone home.

November 26 of 1915 would see perhaps the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the Suvla Bay area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches - although no Newfoundlanders were to be among that number. Numerous, however, were those afflicted by trench-foot and by frost-bite.

As the days, weeks and months passed at Suvla Bay, the British position there was to become more and more untenable and thus on the night of December 19-20, they abandoned the area - the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard.

Some of the Battalion personnel were to be evacuated to the nearby island of Imbros, some to Lemnos, further away; but in neither case would the respite be of a long duration; the 1st Battalion would be transferred only two days later to the area of Cape Helles, on the western tip of the Gallipoli Peninsula.

The British, Indian and Anzac forces – the Australian and New Zealand Army Corps was also to serve at Gallipoli – were by now only marking time until a complete withdrawal of the Peninsula could be undertaken.

This final operation took place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rearguard on this second occasion also.






No sooner had the British evacuated the entire *Gallipoli Peninsula* in January of 1916, than the Newfoundland Battalion was to be ordered to the Egyptian port-city of Alexandria, to arrive there on the 15<sup>th</sup> of that month. The Newfoundlanders would then immediately be transferred southward to the vicinity of Suez, a port at the southern end of the Canal which bears the same name, there to await further orders since, at the time, the subsequent destination of the British 29<sup>th</sup> Division had yet to be decided\*.

\*Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was soon to become a theatre of war.

After a two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and other ranks of the 1<sup>st</sup> Battalion boarded His Majesty's Transport Alaunia at Port Tewfiq, on March 14 to begin the voyage through the Suez Canal en route to France. The Newfoundlanders would disembark eight days afterwards in the Mediterranean portcity of Marseilles, on March 22.




Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.

Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they then marched on their way from the station. But some three months later *the Somme* was to have become a part of their history.

On April 13, the 1<sup>st</sup> Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive re-enforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the *Western Front*.

Just days following the Newfoundland Battalion's arrival on the *Western Front*, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit\* before the entire Newfoundland unit was then ordered to move further up for the first time into forward positions on April 22.

\*It should be said that the Newfoundland Battalion and twohundred men of the Bermuda Rifles who were serving at the time in the 2<sup>nd</sup> Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, *the Somme*, that flowed – and still does so today – through the region.

The month of May must have been a difficult period for young Private Winter: several telegrams from influential sources in Newfoundland would be received by the authorities to request that he be granted a special leave to visit his dying mother in New York. Permission, however, was not given.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went over the top in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later\*.

\*Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been *killed in action* or *died of wounds*.

It was to be the largest disaster *ever* in the annals of the British Army...and, perhaps just as depressing, the carnage of *the Somme* was to continue for the next four and a half months.

In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.

The son of Thomas Winter, co-founder of *T. & M. Winter*, and Florence Winter (née *Belcher*, deceased June 27, 1916) of Rennie's Mill Road, St. John's – post-1916 mail sent to c/o Mrs. Sharpe of Queen's Road and, later again, to 117, Gower Street - he was also brother to Louis-Thomas, Edith-Coen (Cohen?), Francis-Henry and Mildred-Justine (twin), Thomas-Henson, Helen-Belcher, Margaret-Irene, Marion-Belcher and to Marmaduke-G..



Private Winter was at first reported as *missing in action* at Beaumont-Hamel on July 1, 1916, while serving with 'C' Company during the fighting of the first day of *the Somme*. He was officially *presumed dead* some six months later, on December 31.

However, in a document subsequently submitted by the Burial Officer of VI Corps and dated December 12, 1917, it was reported that his remains had been identified and buried just to the south-west of Beaumont-Hamel.

Private Winter's file was thus amended on December 26 of 1917, so as to read...killed in action or died of wounds on or shortly after 1/7/16.

A monument in the old Anglican Churchyard in St. John's records his death at seventeen-and-a-half years of age. (A second source has Edward Rozier Winter enlisting at nineteen; family records simply cite born 1898/1899.) The year appears to have been 1898.
