

Youden



Seaman Thomas Youden, Number 670x, having no known last resting-place, is commemorated on a bronze beneath the Caribou in the Newfoundland Memorial Park at Beaumont-Hamel.

Having decided to volunteer for the Royal Naval Reserve (Newfoundland), Thomas Youden initially presented himself for enlistment on January 24 of 1909, whereupon he was to undergo twenty-eight days of training, until February 21 of that same year.



As with the majority of pre-War volunteers, he had joined for five years and had undergone the required annual training during twenty-eight days per annum of each of the following four years, if not more often, as well. January of 1914 and the first day of February had seen what would have been his final term of service on *Calypso* and also his last medical assessment before the events of that summer were to dictate a call to fulfil his obligations.

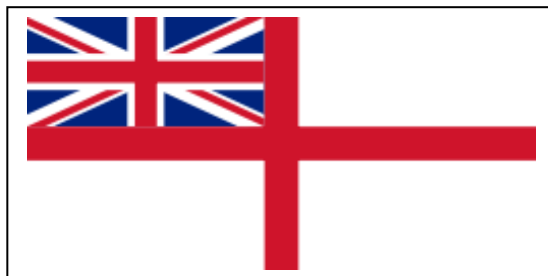
However, summoned from home to service soon following the onset of hostilities, Thomas Youden travelled from his home in Brigus to St. John's, capital city of the Dominion of Newfoundland where, on August 18 of 1914 – two weeks after the British *Declaration of War* – he was once again to report...to duty...to the Naval Reserve training ship, HMS *Calypso*, moored in the harbour (see below).

On that above-mentioned August 17, Thomas Youden was signed on to serve for wartime service* and it was likely to have been at this time – if he had not already done so - that he also attested, pledging his allegiance to the King-Emperor.

***At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist. Later recruits – as of or about May of 1916 - signed on for the ‘Duration’ at the time of their original enlistment.**

***The Union Flag is commonly referred to as the ‘Union Jack’; this is, in fact, a misnomer since a flag is referred to as a ‘Jack’ only when flown from the bow of a ship.**

Note: During the years preceding the Great War the only military force on the Island of Newfoundland – apart from a handful of ill-fated local attempts – was to be the Royal Naval Reserve (Newfoundland). Even so, it was to be some thirty years after the withdrawal of British troops from the Dominion in 1870 before the Reserve came into being in 1902.

Just fewer than four-hundred men were sought to enroll as seamen – apparently automatically at the rank of Able Seaman - and to present themselves annually in St. John's for five years in order to train for a period of twenty-eight days per annum. Allowed to report at a time of their own choosing, it is perhaps not surprising that these volunteers – mostly fishermen – were to opt to train during the winter months when fishing work was at a minimum.

Expenses were apparently defrayed for the most part by the British (Imperial) Government and an attempt was made to ensure the number of recruits would be kept constantly at a maximum. This practice and policy was then to be continued up until the onset of hostilities some twelve years later.

Of course, the purpose of having a reserve force at any time is to provide a trained force ready at any time to serve at a time of need or crisis. Thus in August of 1914, upon the Declaration of War by the government in London, hundreds of those men of the Royal Naval Reserve (Newfoundland) were to make their way to St. John's, from there to take passage overseas to bolster the ranks of the Royal Navy.



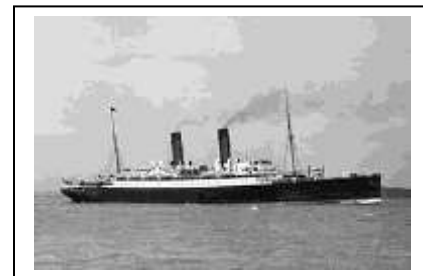
An elderly vessel, H.M.S. 'Calypso', having become surplus to the Admiralty's needs, had been provided to the Dominion of Newfoundland by the Royal Navy in 1902 for training purposes. After some debate it was eventually decided that she would be permanently moored in the harbour of the capital, her superstructure reduced, and a wooden shelter built on her upper deck to provide training facilities and living quarters for the prospective naval recruits.

Following some three months of duties in St. John's – no further training has been recorded - Seaman Youden, one of a draft of three-hundred five naval reservists, embarked on November 5-6 onto the Cunard ocean-liner Franconia on its way serving its commercial route from New York to Liverpool.

Once having arrived in the port-city of Liverpool on November 11, it appears that several of the men were posted directly to a ship. Others were ordered to undergo further training at various Royal Navy establishments and thus, likely having journeyed by train, reported to these bases only hours later. Seaman Youden was among the latter number.

On an unspecified mid-November day, Seaman Youden was...taken on strength...at HMS Excellent, the Royal Navy gunnery school by then located on Whale Island at the entrance to the harbour at Portsmouth. He was to train there until December 11 when he was ordered to join his ship, HMS Viknor, likely destined to serve one of the guns with which by that time the ship had been fitted.



***HMS 'Excellent' was the name – and also still is the name - of the Royal Navy's Gunnery School which had been established in a ship of the same name in 1829, the vessel being permanently moored just outside Portsmouth dockyard. As the years passed the ships were to be replaced, but each in turn was to be named HMS 'Excellent'.**

The Armed Merchant Cruiser *Viknor* was an elderly ship, obsolete and apparently under-powered with a top speed of only fourteen knots. In her earlier lives she had firstly been, as of 1888, the SS *Atrato*, before then having been re-named as the SS *Viking* in 1912. Upon the outbreak of the *Great War* in 1914 she had been requisitioned by the British Admiralty and baptized on that third occasion as HMS *Viknor*.

At the time of Seaman-Gunner Youden's transfer to *Viknor*, the ship was apparently based on the River Tyne. She was not to leave port until December 28 and not to join her squadron (see below) until January 1. She had been armed by that time although the type of weapon that Seaman Youden was to serve appears not to have been documented.

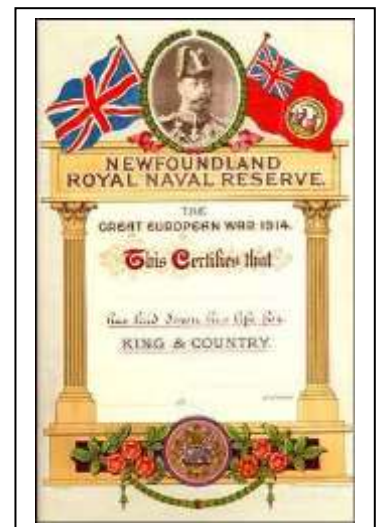


'*Viknor*' was to be attached to the 10th Cruiser Squadron, also known as the *Northern Patrol*, a force originally having comprised out-of-date warships which, by that January of 1915, had proved unequal to the elements and had been replaced by requisitioned ocean-going passenger-liners carrying a few guns, those at times older than the ships on which they were mounted.

The ships of the 10th Cruiser Squadron, although armed, were not spoiling for a fight. Their job was to form a part of the naval blockade designed to prevent ships carrying goods to Germany from reaching their destination; to accomplish this these vessels had to patrol the stormy waters encompassed by northern Scotland, Ireland and Iceland, a thankless job at the best of times: during the tempestuous winter months, even worse.

In early January the ships of the *Northern Patrol* stopped a Norwegian vessel, the *Bergensfjord*, and transferred a number of persons, one of them a suspected spy, to *Viknor*, she then being ordered to proceed to Liverpool.

From what is known about *Viknor*, she was hardly a vessel fit for the task at hand and January and February of 1915 were to apparently be particularly stormy. What is more, a German counterpart, the steamship *Berlin*, had recently been reported in the area sowing mines – one of which had sunk the battleship *Audacious* some three months before.

It still remains a bit of a mystery as to what happened to *Viknor* although it appears to be that either she fell victim to the bad weather or that she was sunk by a mine. All that may be sent with any great certainty is that there was not to be a single survivor: of the crew of three-hundred two, including twenty-five of the Royal Naval Reserve (Newfoundland), all were to perish*.

**Her wreck was found off the coast of County Donegal, Ireland, in the year 2006, but no conclusion was to come about as to the cause of the ship's sinking.*



The son of Henry (also found as *Harry*) Youden and of Jessie Louise Youden (née *Bartlett**) of the Conception Bay community of Brigus, he was also brother to Philip, James-Augustus, Absolom (but perhaps known as *Albert*), George-Henry**, Frederick, Jessie-Josephine, Samuel, Joseph-Bartlett and also to John-Henry.

**The couple had married on November 29 of 1876. Their son Thomas Youden had also married, in Georgetown, Brigus, on November 9 of 1911, to Alice Walsh, and had lived in nearby Bull Cove although the home address of his wife also appears in one source as Sydney, Nova Scotia. By the time of Thomas' departure for overseas service, the couple had parented a single child, Jessie-Louise born in 1912, while a second, Mary-Elizabeth, was to arrive in November of 1914.*

***George Henry Youden was also to serve in the Royal Naval Reserve (Newfoundland) and had enlisted in the same year as Thomas. He took passage for overseas service to the United Kingdom on board the Cunard vessel 'Franconia' and subsequently trained at HMS 'Excellent' as did his brother.*



Likewise he was attached to the ill-fated 'Viknor' and lost his life with his brother on that January 13 of 1915. His history, almost identical to that of Seaman Thomas Youden is to be found elsewhere in these files.

Seaman-Gunner Thomas Youden died on January 13 of 1915, at the *reported* age of twenty-six years: date of birth in Brigus, Newfoundland, May 17, 1886 (from his enlistment papers).

Seaman Youden served only in the Royal Navy and was not in the service of Canada as is cited in some sources, notably the Commonwealth War Graves Commission.

Seaman-Gunner Thomas Youden was entitled to the 1914-1915 Star, as well as to the British War Medal and the Victory Medal (Inter-Allied War Medal) (right).
