Here I am at last <sup>having</sup> ~~after~~ come to this city

Another favour now & I'm finished yet Major Parsons to send me on a certificate that I'm to receive treatment - my last board as you know gave me another three months & a rise in my pay - I don't think - for I find my hands requiring further treatment. As far as I can see we have some association here for sold men for according to the papers the least little thing & they are up in Arms. What a difference from St Johns - I'll say no more on this - Hope you will find time to attend to the above & trust you are keeping well. Remember me to any of the old boys & not forgetting them all at Hillstead. Sincerely yours Sam Eaton
