Pto. Incidence had two young brothers who were both it Hount Cashel before he enlisted. Both father and mother are dead, one boy age 14 years is stated to be mentally deficient and the other age 15 years has just had an operation in the hospital and had one leg amputated from the hip (tubercular). Hrs Jackman realizes that as the allotment was payable to her and as Hr. Jackman is alive she is not entitled to pension or allotment that she was receiving might be expended for the benefit of these two young brothers.

The case is now brought before your attention see if it is possible to have a pension allowed in favour

of these younger brothers. I should e glad to received your reply giving the finding of the Board.
